## Light Brown Apple Moth Discovered in Yolo County- Quarantine Extends into Solano County



### The detection of a second Light Brown

Apple Moth (LBAM) in Davis on May 14 has invoked a state interior quarantine around the City of Davis, extending into a small portion of Solano County. The county is already under a federal quarantine that regulates the shipment of products and material from the county to other states, due to the LBAM presence in the Vallejo/Benicia area. The first Davis LBAM detection was discovered in early April.

The new quarantine is necessary to prevent the further spread of LBAM and the associated consequences to agriculture. The quarantine on

the intra-California movement of affected material will impact production and retail nurseries, fruit and vegetable producers, community gardens and farmer's markets. In order to move products out of the quarantine area to other areas within the state, it will be necessary for producers to enter into a compliance agreement with their local agricultural commissioner's office.

The current state quarantine area for a LBAM infestation is 1.5 miles. The Solano County portion of the quarantine is in the immediate area south of Davis, encompassing the area north of the South Fork of Putah Creek. If more LBAM are detected in the area the interior quarantine may expand.

The LBAM is native to Australia and is found in New Zealand, the United Kingdom and Hawaii. The range of host plants is broad with more than 2,000 plant species known to be susceptible to attack by this pest, and more than 250 crops. The moth feeds on host plants and causes damage or spoils the appearance of ornamental plants, citrus, grapes and deciduous fruit tree crops.

They also study problems of general or special interest and make recommendations that promote the County's agricultural interests. The committee meets the second Wednesday of every month from 3-5.

## Solano County Agricultural Production Values Up 9% in 2008

Increasingly favorable commodity prices helped set an all-time high for agricultural production in Solano County for the second year in a row.

The gross value of the more than 80 crops was \$292.8 million in 2008, up almost \$25 million, or 9 percent from the previous year, according to the *Solano County Crop and Livestock Report* released May 28.

"While the gross value is a record high, it does not reflect the total contribution of agriculture. Transportation, processing, marketing and other farm-related services re-spend agricultural dollars to the benefit of the local economy and pushes that number even higher," said Solano County Agricultural Commissioner Jim Allan.

Nursery products remained the No. 1 crop at \$43 million; however, its value plummeted 24 percent from its all-time high of \$56.6 million in 2007.

"The nursery industry was hit hard by the economy, with fewer housing starts lowering demand for ornamental plants. However, nursery products remain a significant aspect of Solano County's agricultural efforts," Allan said.

Values increased in nearly all field crops due to favorable commodity prices, overcoming lower yields related to drought conditions. Field crops were valued at \$89.4 million, up 63 percent from \$54.8 million in 2007. Alfalfa and processing tomatoes experienced both higher commodity prices and increased yields.

An added element of the Crop Report focuses on the international trade. Thirty-seven commodities, including endive, grapes, tomatoes and hay, are exported to 45 countries across six continents.



## General Plan Implementation Update



### SUISUN VALLEY STRATEGIC PLAN DEVELOPMENT

The Strategic Plan Development process is well under way in the Suisun Valley. The last of three Stakeholder Working Sessions was conducted on April 20. These meetings provided Suisun Valley stakeholders and the public with an opportunity to provide input on the planning processes under development by the planning consultant, EDAW. There will be a Community Workshop on June 29, (see upcoming events) in which elements of a draft Strategic Plan will be presented to the public. From there, the draft plan will be put together and then released for public comment prior to presentation to the Planning Commission and ultimately the Board of Supervisors this fall.

### DIXON RIDGE STRATEGIC PLAN DEVELOPMENT

The Community Kickoff Meeting for the Dixon Ridge Strategic Plan development process was held at Dixon City Hall on April 22. More than 40 stakeholders from the Dixon area showed up receive a presentation from County Staff, Jim Louie and Adam Cline, and participate in a discussion facilitated by Larry Clement.

Jim and Adam are currently busy meeting with various stakeholders in the Dixon Ridge region to talk about the Strategic Plan and receive feedback. Another public meeting is going to be scheduled this fall, when stakeholders can review drafting planning processes and provide comment.

### Opening on Farm Service Agency's County Committee

Each year the Solano County Farm Service Agency (FSA) office conducts County Committee elections to fill the vacancy of one area representative. For 2009, the FSA is seeking nominees to fill the LAA 3 district seat, which represents northeast Solano County, east of Highway 505 and north of Air Base Parkway and Hay Road. Craig Gnos has represented the local area for the past 9 years and now must sit out a year.

County Committee members help with the decisions necessary to administer FSA programs in their counties. Specifically they provide input on commodity price support loans and payments, conservation

programs, emergency programs, and incentive, indemnity and disaster payments for some commodities.

In order to be eligible to serve on the county committee, one must be an active producer in the LAA 3 district. Individuals may nominate themselves. The deadline for submitting nomination forms is August 3, 2009. Ballots will be mailed to eligible voters in November. Elected committee member begin their terms on January 1, 2010.
