Eight Arrested During Sex Registrants Compliance Checks

Over the last week the Solano County Sheriff's Office Investigations Bureau were assisted by the Sheriff's Enforcement Team (SET), the Sheriff's Offices California Multi-Jurisdictional Methamphetamine Enforcement Team (Cal-MMET), the Northern California Computer Crimes Task Force (NC³TF), the Solano County Probation Department, and the State of California Department of Corrections and Rehabilitation / Parole while conducting compliance checks on sex registrants. The agencies combined efforts to conduct compliance checks on registered sex offenders who reside within Solano County. The compliance checks were funded by Sexual Assault Felony Enforcement (S.A.F.E.) Task Force grant that is overseen by the Solano County Sheriff's Office. Compliance checks on registered sex offenders residing within Solano County are done regularly to insure the subjects are adhering to the terms of their registration, probation, or parole.

The Solano County S.A.F.E. Task Force is one of 12 participating county agencies in the Region II S.A.F.E. Task Force. The participants within the task force receive grant funding each year from the California Emergency Management Agency. The mission of the Region II S.A.F.E. Task Force is to reduce the number of non-compliant sex registrants within the region. The 12 counties involved in the task force work together to achieve this goal. Solano County Sheriff's Office has been a member of the Region II S.A.F.E. task force since 2008.

Thomas Douglas, 49 year old Vacaville resident for violating the terms of his parole.

Kevin Henderson, 24 year old Vallejo resident for violating the terms of his parole.
