**INFORMATION RELEASE**  
**ONE SUSPECT IN CUSTODY AFTER MAN SHOT IN VALLEJO**

**11/30/13**

On Friday 11-29-13 just before 2 p.m. the Vallejo Police Department received a call regarding a subject who had been shot in the area of Sacramento Street and Hwy 37. Vallejo Police Department notified the Sheriff's Office because the location is on the edge of the Vallejo city limits and near the Sheriff's Office jurisdiction.

Sheriff's Deputies responded to the area, met with Vallejo Police Department officers, and located the victim who had two bullet wounds. The area is just outside the City of Vallejo and is known to be frequented by homeless in the area. Medical personnel were called to the area to treat the victim and the victim was transported to a local hospital for treatment. The victim was listed in stable condition at the time of this release.

While on scene deputies received information from the victim that he had been shot by two adult males after an argument. The victim also told deputies that the two males had fled the area on a small aluminum boat after shooting him.

Deputies notified local law enforcement and the US Coast Guard Station out of Vallejo and advised them of what had taken place. Deputies put out a description of the two wanted suspects and the boat they had fled in. A short time later a US Coast Guard boat stopped a boat matching the description in the area of the San Pablo Bay. The boat was determined to be the boat that had fled the area after the shooting and the solo occupant was taken into custody without incident. The US Coast guard transported the suspect and the boat to the US Coast Guard Station in Vallejo and the suspect who was identified as 58 year old **John Sauerzopf** of American Canyon. Sauerzopf was later booked into the Solano County jail and charged with attempted murder and conspiracy, both felonies.

Investigators from the Sheriff's Office are continuing their search for the second suspect and he has been identified as 52 year old **Wayne William Robbins** who is listed as transient out of Vallejo. The investigation into this incident is continuing and an arrest warrant has been issued for Robbins.
