ADMINISTRATIVE APPROVALS

- 1. Request for a 1 year extension to exercise Use Permit No. U-13-06 of AT&T (c/o SAC Wireless of CA, Inc.) for a new wireless telecommunication facility consisting of two structures. The property is located south of the intersection of Lyon Road and Cherry Glen Road, approximately 1 mile north of the City of Fairfield in an "A-20" Exclusive Agricultural Zoning District, APN: 0122-120-030. (Project Planner: Eric Wilberg)
- 2. Extension No. 6 to Use Permit No. U-82-52 of **Niki Howlett** for the continued operation of a repair and storage facility for farm equipment used in commercial farm trucking and harvesting operations. The project is located on the south side of Fry Road, ¼ mile east of Leisure Town Road, Vacaville, in an "A-40" Exclusive Agricultural Zoning District, APN: 0137-020-130. (Project Planner: Eric Wilberg)

3. **PUBLIC HEARING** to consider Minor Use Permit Application No. MU-14-03 of **Verizon Wireless (c/o NSA Wireless)** to construct a wireless communication facility atop an existing 97.9 foot tall PG&E lattice tower. The Verizon site would consist of six panel antenna mounted on a 12 foot tall "top hat" tower extension. Equipment cabinets would be located within the base of the existing tower on a raised steel platform with redwood enclosure fencing. The project is located at Gates Canyon and Vaca Valley Roads, Vacaville, in an "A-40" Exclusive Agricultural Zoning District, APN: 0121-150-100. This consideration has been determined not to have a significant effect on the environment and is categorically exempt from the California Environmental Quality Act.
