DISCUSSION:

A. Fee revision and RV Dump Station status update:

Staff Recommendations

- Installation of pay per use automated system for access to waste dump station.
- Non camper dump fee reduction from \$19-\$15.
- Adoption of Dump Station Fee of \$15.

Background

- Trend of increased use of dump station service resulting in increased operational expense and very minimal offset with current fee structure.
- Unauthorized use (use without payment)
- Observed multiple uses per visit
- Industry transition away from our existing model to proposed model
- Recent transition away from leach field to vault system due to state and local regulations
- User trend towards increased recreational vehicle use
- Not all campers who use the utility sites are using the dump station

Possible Outcomes of Staff Recommendations

- Reduced use of dump station (reduces pump out expense)
- Consistent use of dump station (operational expense is partially offset by revenues received for the use of the service)
- Dump station users are unhappy with added cost
 - Mitigation tactics such as education program (interpretive signage, pamphlets, and use of Parks website), delayed rollout out program to coincide with beginning of calendar year occurring during the Off Peak Season.
- Supplies supporting documentation of volume of use, patterns of use, and confirmation of prevention of potential contamination; potentially promoting connection to city sewer system in the future.
