PURPOSE STATEMENT – Community Correction Partnership

The mission of the Community Corrections Partnership (CCP) is to discuss issues related to the implementation of various pieces of state legislation that focus on adult criminal offenders, including the realignment of many state public safety functions to local jurisdictions. The overall objective is to reduce the recidivism rate of adult offenders in the local criminal justice system.

Membership of the CCP is defined by the Community Corrections Performance Incentive Act of 2009 (SB 678) and includes the Chief Probation Officer (Chair)*, Presiding Judge of the Superior Court*, a County Supervisor or County Administrator, District Attorney*, Public Defender*, Sheriff*, the head of the Department of Social Services*, the head of the County Department of Mental Health, the head of the County Department of Employment, the head of the County Alcohol and Substance Abuse programs, the County Superintendent of Education, a local chief of police*, a representative of a community-based organization with experience in successfully providing rehabilitative services to persons convicted of criminal offenses, and an individual who represents the interests of victims.

Through AB 109/AB117 the CCP is responsible for recommending a local plan to the county Board of Supervisors (BOS) for the implementation of the 2011 public safety realignment. This legislation also established an Executive Committee within the CCP. Each Executive Committee member is identified with an asterisk (*) above. The Executive Committee is responsible for approving the local plan for recommendation to the BOS.

Call to Order

The meeting was called to order at 3:00 p.m. Chief Hansen welcomed and requested introduction of members.

Approval of Agenda

Patrick Duterte made a motion to approve the agenda. The motion was seconded by Lesli Caldwell. No opposition. Motion carried.

Approval of Minutes

Patrick Duterte made a motion to approve the minutes. The motion was seconded by Don du Bain. No opposition. Motion carried.

Public Comment

An opportunity was provided for members of the public to address the committee on matters not listed on the Agenda. No comments.

Data Report *(See Handout - PowerPoint) – Probation Department and Sheriff's Office Statistics*

Donna Robinson presented statistical information pertaining to the Postrelease Community Supervision (PRCS) population for the month of June 2012.

- 298 Offenders under supervision for PRCS
- 3 Grants expired; 5 Grants revoked
- 38 Failed to report to Probation since October 2011
- 26 Transferred out of Solano County since October 2011
- 8 Transferred in since October 2011
- 15 Required to report to Probation (June 2012)
- 32 Packets received (June 2012)
- 5 bench warrants ordered; 7 warrants cleared (June 2012)
- Cities w/highest PRCS: Vallejo 37%; Fairfield 34%; Vacaville 15%; Suisun 6%; Dixon 7%; Rio Vista & Benicia 1%
- Risk Level of Re-offending: Very High 13 %; High 57 %; Medium 17%; Low 1%
Pending Assessment: 12%
- Ethnic Profile: African American 43%; Caucasian 36% Hispanic 16%; Other 5%
- Gender Profile: Male 91%; Female 9%
- Committing Offenses (Males) Theft, Drugs and Weapon Charges
- Committing Offenses (Females) Theft, Drugs, and Forgery/Check Fraud

The Probation Department is currently entering cases into the Supervised Release File (SRF) system. Once all offenders are entered, the SRF system will be used prior to requesting a bench warrant. Offenders who fail to report to Probation or abscond from jurisdiction will be entered in the SRF system for up to 60 days. If the offender is not contacted by law enforcement within the 60 day timeframe, a warrant will be initiated at that time. The Probation Department plans to have all offenders entered in the system and procedures in place by August 2012.

Gary Elliott provided statistical information pertaining to the jail population as a result of Public Safety Realignment for the month of June 2012.

- Jail Population: 892
- Parolees (3056): 149 in custody represents 16.7% of jail population
- 1170(h) (N3's): 155 in custody represents 17.3 % of jail population
- PRCS: 24 in custody represents 2.7% of jail population
- Statistical information was presented on compliance checks as of January 24, through June 5, 2012

Data Subcommittee Report

Gary Elliott provided information from the Data Subcommittee. On July 10, 2012, representatives from the Department of Justice (DOJ) attended the Data Subcommittee meeting and discussed the SRF data sharing system. The DOJ was impressed with the number of packets entered into the system. Solano County will participate in a three-county pilot project with DOJ to understand challenges of data collection at the local level.

DRC and Substance Abuse/Mental Health Subcommittee Report *(See Handout-DRC and MH/Substance Abuse Subcommittee Report)*

Patrick Duterte reported the Day Reporting Center and Substance Abuse/Mental Health Subcommittee met on June 29, 2012 and July 10, 2012 to identify challenges, develop a vision, and set goals and objectives which encompass a continuum of care. The committee affirmed the eight core elements of the DRC Framework. The Probation Department will assume oversight and administrative responsibilities for the DRC in Solano County.

Donna Robinson reported on the future progression of the DRC. The Subcommittee established four operational workgroups which will be responsible for obtaining detailed information on the core elements of the DRC. The workgroups will work independently and provide updates to the CCP. Please see below contact information for those interested in participating in a workgroup:

Chief Hansen questioned the validity of having Mental Health treatment at the DRC or to refer clients back to Mental Health.

Belinda Smith recommended spelling out acronyms on future documents.
