#### National Sword Hauler's updates:

Tom Phillips, Recology Vallejo: is the only transfer station in Solano County, it processes the recyclables generated curb side for the cities of Dixon, Vacaville, Vallejo, and unincorporated Solano County. Recology is currently moving material at a discounted rate. Secondary markets are not offering much for materials therefore it's not enough to cover processing cost. Rates are about the same as reported in July and fluctuate daily. Loosing money on the paper side and have recently given paper away. On the metal side aluminum and steel prices are good. Plastics and are okay. Mixed material and rigid plastics are a challenge to move. Communicating with local jurisdictions seeking rate recovery relief. Issues they would like to see addressed are should they be collecting 3-7. Also, have slowed down processing to reach acceptable contamination level.

Kevin Flanagan, Republic Services Fairfield: Recyclables generated curb side in the cities of Fairfield, Suisun City, Travis Air Force Base, and unincorporated Solano County. Recyclables formerly processed in the City of Benicia at Pacific Rim Recycling; they shut down a year ago

due to National Sword. Currently trucking material to facility in Newby Island that is regulated by the City of San Jose LEA. Slowly moving material at a lower price. 3-7 are a challenge.

Sara Davis, Mount Diablo Resource Recovery: Launched Recycle Clean America campaign to educate customers that they are no longer accepting 3-7.

Natalie Hicks, Potrero Hills Landfill: Increase in residual waste.

### b. Legislative Update

CA Product Stewardship Council (CPSC) was formed in 2007 due to no disposal bans without management plans. In 2000 Department of toxic substances control (DTSC) banned Cathode Ray Tube (CRTs), batteries, HG lamps, and sharps without any plan or funding to manage them. Local governments have reached 50% and now need producers and retailers to help reach zero waste. Product Stewardship is primarily voluntary producers of products redesigned for durability, reparability, reuse or recycling. Types of stewardship products consumers are paying upfront recycling fees for are tires, carpet, paint, and mattresses. Funds go into programs like bye bye mattress, paintcare, and California Carpet Stewardship Program which dispose and recycle products. Extended Producer Responsibility (EPR) is were manufacturers decide how to make products and are making a profit. Manufactures should share cost in the end of life of product and help design greener so it's easier to recycle. Examples of EPR products are thermostats, Ag pesticide containers, recalled products, and rechargeable batteries.

Campaigns that are promoted are "DON'T RUSH TO FLUSH" and "REFUEL YOUR FUN & \$AVE". Information can be viewed on Calpsc.org. Current focus is propane cylinders, meds, and sharps. National parks are paying \$6.50 a piece for propane cylinder disposal. Have promoted exchange events through grants to bring in two propane cylinders and get a refillable propane container for free. SB 212 does convenient meds disposal it establishes a statewide comprehensive, producer-funded take-back program to provide safe and convenient disposal options for home-generated pharmaceutical drugs and sharps waste. Aids in prevention get excess drugs out of people's homes, helping in the prevention of accidental poisonings and abuse, which has one of the main contributors fueling the opioid epidemic. Free safe needle disposal requires distribution of free safe disposal sharps containers with every needle sold. Protection helps solid waste, parks, hotel, wastewater, sanitation, and other workers, river and beach clean-up volunteers, and the public from accidental needle stick injuries. Enforcement regulation by CalRecycle. CalRecycle to adopt regulations no later than January 1, 2021. SB 212 is on governor's desk waiting for signature. Once SB 212 is signed Cal Recycle staff will begin regulation process. It will take approximately three years to begin. In the meantime, jurisdictions are not going to want to pass an ordinance to require the manufactures to pay for this. That does not mean they are not able to pass an ordinance that tells retailers to take back products. Idea is to get retailers and pharmacies on board now so when the law goes into effect there are existing locations. How do we fund stop gap? CPSC has already identified about \$3 million that may be available to cover the stop gap time. If interested in starting a program contact CPSC they can assist with obtaining grant money. Ways to help are adopting EPR resolution, get EPR in your legislative platform, include EPR in your Procurement Policies, EPR in zero waste and solid waste planning documents, help fund CPSC, contract with CPSC for grants applications and implementation, start stewardship arrow awards.

Samantha Brown, City of Vacaville: Purchased 1300 no plastic bag stickers focusing on multifamily dwellings and rolled it out to high contamination areas. Had first waste characterization study a couple of weeks ago will be meeting on Monday to go over study. Hoping to see some impact over a three-month period. Ordered another 1300 stickers to expand program.

Sharon Williams, City of Benicia: Has a compost give away in August.

Marie Knutson, Republic Services Benicia: Began empty clean dry campaign for recycling to educate residents on the difference between bio-degradable and compostable ego ware.

Marcy Hannum, Solano County LEA: Recology Hay Road is going through a permit revision to extend their hours. Currently they are closed four holidays out of the year and would like to be opened 365 days of the year.

Narcisa Untal, Solano County: Solano County unincorporated is moving forward with a second reading of an ordinance to join Marin Clean Energy. Marin Clean Energy is a community choice aggregation program an alternative third party to PG&E for electricity only. They currently contract with Recology Hay Road for the waste to energy. Will now have that as part of power supply mix. This applies only to unincorporated Solano County. Approximately 7500 customers in total, with the anticipation of a 10-15% opt out. Solano County unincorporated will now join the City of Benicia as the only two Solano County jurisdictions that are part of the Marin Clean Energy service area which includes all of Napa County, Marin County, and most of Contra Costa County. They are now 1 of 18 authorized community choice aggregation programs in the State of California. Renewables is where the future is going since the governor did sign SB 100 on Monday which now mandates 100% clean energy coming from renewables by 2045. Requested everyone to notify her if they will attend November 15, 2018 meeting.
