The Solano County Planning Commission met on September 16, 2021, in regular session in the Board of Supervisors' Chambers at the Solano County Government Center, 675 Texas Street, Fairfield, California at 7:00 p.m.

Present were Commissioners Kay Cayler (via WebEx), Michael Reagan, Kelly Rhoads-Poston (via WebEx), and Chairperson Paula Bauer. Also present were Resource Management Director Terry Schmidtbauer, Planning Manager Allan Calder, Senior Planner Kristina Heredia, County Counsel Jim Laughlin, and Clerk Marianne Richardson.

ROLL CALL

Kay Cayler (via WebEx), Michael Reagan, Kelly Rhoads-Poston (via WebEx) and Chairperson Paula Bauer.

APPROVAL OF AGENDA

Chairperson Bauer announced notification of withdrawal of Regular Calendar appeal item No. PC-21-018. County Counsel Jim Laughlin stated confirmation of receipt of communication from applicant's attorney of withdrawal.

On a motion by Commissioner Reagan, and seconded by Commissioner Cayler, the agenda was approved with removal of item No. PC-21-018 from the Regular Calendar. So ordered by 4-0 vote.

APPROVAL OF THE MINUTES OF AUGUST 19, 2021

Chairperson Bauer stated revisions to the Call to Order and Roll Call sections to indicate Commissioner Rhoads-Posten attended via WebEx, and County Counsel Jim Laughlin was present.

With no opposition from commissioners, the minutes were approved with revision by affirmation.

- 3.) Melissa Neal, residing at 4363 Edinburg Court, spoke against the vacation rental appeal item withdrawn from the calendar and of the financial impacts to the County.
- 4.) William Fell, residing at 4320 Edinburg Court, spoke against the vacation rental appeal item withdrawn from the calendar speaking of fire danger concerns and photographs of rental activity.

Chairperson Bauer asked Mr. Fell if he has sent his photos to the County. Mr. Fell responded he has submitted some, and could provide more photos. Deputy County Council Clarisa Sudarma stated that Code Enforcement was in receipt of Mr. Fell's photos.

Commissioner Reagan stated that he hoped the County could set penalties to absolve the expense to the community.

Planning Manager Allan Calder introduced a new Planning Division staff member, Senior Planner Kristina Heredia, who will be presenting items to the Planning Commission in the near future.
