STORAGE OF WASTE TIRES

- Not to exceed 6 feet in height when within
 20 feet of any property line.
- Not to be located within 10 feet of any property line.
- Separated from vegetation and other potentially flammable materials (inner tubes)
 by no less than 40 feet.
- Accessible fire lanes between storage units unobstructed at all times.
- Surface water drainage directed around and away from storage area.
- Tires must be removed from rims immediately upon arrival at the facility.



VECTOR CONTROL MEASURES

Waste tires shall be stored in a manner which prevents the breeding and harborage of mosquitoes, rodents, and other vectors by providing cover with impermeable barriers or use of treatments or methods to prevent or eliminate vector breeding as approved appropriate by the local vector control authority.



BACKGROUND

In 1990, the California Legislature enacted comprehensive requirements for the storage and disposal of waste tires. These requirements were intended to address potential fire and health risks posed by tire piles in California. As a result of these statutes, the California Integrated Waste Management Board (CIWMB) adopted regulations for the permitting of waste tire facilities. In January of 2010, CIWMB was reorganized and began operating under a new name—Department of Resources Recycling and Recovery (CalRecycle).

What is a "Waste Tire"?



Α

waste tire is a tire that is removed from the vehicle and is no longer suitable for its original intended purpose due to wear, damage or defect. A waste tire includes a repairable tire, scrap tire,

What is a "Used Tire"?



A used tire is a tire that is no longer mounted on a vehicle but is still suitable for use as a vehicle tire, is stored by size in a stack or a rack not more than two (2) rows wide and each tire can be individually examined.

REGULATORY AUTHORITY

The Waste Tire Statutes and Regulations authorize CalRecycle to regulate:

- Generators of waste or used tires
- Transportation of waste or used tires
- Storage and disposal of waste and used tires



USED AND WASTE TIRE GENERATOR & END-USE FACILITY REQUIREMENTS

Generators & End-Use Facilities are required to comply with regulations as follows:

- Release waste tires only to registered waste tire haulers and use Comprehensive Trip Log (CTL) forms (if more than 9 tires).
- Maintain waste tire manifests and records for at least three years.
- Obtain and use a Tire Program Identification (TPID) number from CalRecycle.
 Generators must post the TPID certificate in a conspicuous place.

It is the generator's responsibility that all disposal documentation is accurately completed. By initialing/signing incomplete **CTLs** or manifests, a generator subjects him/herself to enforcement.



WASTE TIRE HAULER REQUIREMENTS

Effective January 1, 2001, any person who transports ten (10) or more used or waste tires is required to be registered as a waste tire hauler. Haulers of waste tires are required to:

- Register annually with the CIWMB and keep original registration certificate in the registered vehicle.
- Post a \$10,000 bond.
- Place registration decal on passenger side front windshield of hauling vehicle.
- Have a CTL receipt in possession while transporting waste tires.
- Transport waste tires to a permitted landfill, permitted waste tire facility, or other CalRecycle authorized end use facility.
- Leave a copy of the CTL receipt with the waste generator or end use facility.

STORAGE OF WASTE TIRES

A waste tire facility is a location where waste tires are accumulated for resale, processing, storage, or disposal. If you have:

A) 1-499 waste tires

- Permit is not required from CIWMB
- Obtain a TPID number from CalRecycle by calling (866) 896-0600
- Register with Solano County by calling (707) 784-6765

B) 500-4999 waste tires

- Obtain a "Minor" permit from CalRecycle.
 Obtain a TPID number from CalRecycle by calling (866) 896-0600
- Register with Solano County

C) 5000+ waste tires

- Obtain a "Major" permit from CalRecycle.
 Obtain a TPID number from CalRecycle by calling (866) 896-0600
- Register with Solano County
