### **PURPOSE STATEMENT – Community Corrections Partnership**

The mission of the Community Corrections Partnership (CCP) is to discuss issues related to the implementation of various pieces of state legislation that focus on adult criminal offenders, including the realignment of many state public safety functions to local jurisdictions. The overall objective is to reduce the recidivism rate of adult offenders in the local criminal justice system.

Membership of the CCP is defined by the Community Corrections Performance Incentive Act of 2009 (SB 678) and includes the Chief Probation Officer (Chair)\*, Presiding Judge of the Superior Court\* or his or her designee, a County Supervisor or County Administrator, District Attorney\*, Public Defender\*, Sheriff\*, the head of the Department of Social Services\*, the head of the County Department of Mental Health, the head of the County Department of Employment, the head of the County Alcohol and Substance Abuse programs, the County Superintendent of Education, a local chief of police\*, a representative of a community-based organization with experience in successfully providing rehabilitative services to persons convicted of criminal offenses, and an individual who represents the interests of victims.

Through AB 109/AB117 the CCP is responsible for recommending a local plan to the county Board of Supervisors (BOS) for the implementation of public safety realignment. This legislation also established an Executive Committee within the CCP. Each Executive Committee member is identified with an asterisk (\*) above. The Executive Committee is responsible for approving the local plan for recommendation to the BOS.

Chief Hansen welcomed members and requested introductions. In addition, he welcomed the Chief Walt Tibbet from the Fairfield Police Department, and introduced Melissa Johnson, Criminal Justice Researcher. Melissa will work on the AB109 project and is assigned to the Probation Department.

Dennis Bunting, County Counsel clarified speaking allotments for public comments pertaining to action items. The committee will follow the Board of Supervisors' rules. The public is allotted three (3) minutes to speak on each action item. Public speakers may ask the Chair for additional time, if needed. With regards to public comments, five (5) minutes are allotted.

### **Approval of Agenda**

Patrick Duterte made a motion to approve the agenda. Motion seconded by Lesli Caldwell. No opposition. Motion carried (6-0).

### **Public Comment:**

Robert Schussel - A Vallejo resident voiced his concerns regarding the seating arrangements. He believes this particular arrangement is pushing the public further away from the meeting. He would like tables, for writing purposes, for the public as opposed to just chairs. He is asking the committee to be cognizant of this request.

Mr. Schussel felt the Vallejo City meeting on January 31, 2013, located at the Florence Douglas Senior Center was "staged, condescending, and a waste of time." He felt the public was not being heard. Also he inquired regarding the presence of four (4) Deputy Sheriffs at both City meetings, which he believes wasted over a \$1,000 per meeting of taxpayers' money.

Chief Hansen spoke regarding the Sheriff's Enforcement Team's (SET) presence at the City meetings. He clarified that the four team members were asked to be at the meeting. The SET Team is part of and funded by the Community Corrections Partnership (CCP). The purpose of the team's presence was to answer the public's questions regarding enforcement at the Service Center.

### **Approval of Minutes**

Correction noted for the Jauary 16, 2013 minutes replacing "disturbed" with distributed on page 5.

Richard Word made a motion to approve the minutes. Motion seconded by Don du Bain. No opposition. Motion carried (6-0).

Stephan Betz presented statistical information for offenders referred and receiving services through Health and Social Services from January – December 2012.

### **Public Comments Regarding the Data Report:**

Robert Schussel – A Vallejo resident requested the distribution of a handout explaining CCP acronyms. In addition, he asked for previous criminal statistics (5-10 years) on the 1170(h) (N3's) population.

Don du Bain clarified 1170 (h) inmates are not eligible for local jail treatment if violent or serious felonies have been committed. The PRCS offenders (inmates exiting prison) are released based on their last offense. If the last offense is non-serious, non-violent, or a non-sex offense; inmates are eligible for PRCS supervision under the jurisdiction of the probation department.

**Budget Update:** (See Handout – 2011 Public Safety Realignment (AB109) Budget – February 13, 2013)

Ian Goldberg, Liaison for the Criminal Justice Section of the Budget, gave an overview and explanation of the updates regarding the Public Safety Realignment Budget. In addition, all requests for this meeting were included in the Budget Report handout.

### **Public Comments Regarding the Budget Report:**

No name given: She expressed concerns regarding the Fairfield location and if that will be about 50% of the parolees going to each area.

Chief Hansen stated a discussion will take place when we get to that area of the agenda.

### **CDCR Parole Update:**

Chief Hansen clarified the following for the public: The PRCS population should not be referred to as "Parolees." The correct term is Post Release Community Supervision offenders (PRCS). The terms Parolee and PRCS are not interchangeable. Parolees are supervised by the state. The Probation Department supervises probationers and PRCS offenders released from the California Department of Correction and Rehabilitation (CDCR) under Post Release Supervision.

Deborah Johnson, North Bay District Administrator reported statistical information on active parole cases and violators in Solano County.

- 730 Active Parolees in Solano County
- 90 Additional Parolees are Suspended or in Revoked Status
- Active Parolees by City: 416 Fairfield; 49 Suisun; 294 Vallejo; 92 Vacaville
- 55,000 on Parole Currently down from 120,000 in Fiscal Year 2009-2010
- 30,000 on Parole by Fiscal Year 2015-16

Deborah Johnson reported Parole Offices are being consolidated or closing down monthly. The Concord and Richmond office will consolidate into one Parole Unit, and the Hayward Unit has been closed and moved to the Oakland Unit. The Vallejo office will be moving into the Fairfield Unit. ### **Sheriff's Office Request Update:**

Gary Faulkner reported for the Sheriff's Office, which requested the CCP to approve a recommendation to the Board of Supervisors (BOS) for funding for the purpose of retaining consultants in the fields of evidence-based inmate programming, educational/vocational programming, cognitive behavioral therapy, facility policy and operations to review current programs and policies/procedures in order to develop pro-active programs. Through expanded programming, inmates will receive life-skills' training. Don du Bain made a motion to approve the recommendation for funding. Motion seconded by Patrick Duterte. No opposition. Motion carried (6-0).

Gary Faulkner also requested the CCP approve a recommendation to the BOS for funding, not to exceed the amount of \$107,000, for a 1.0 FTE Program Manager. The Program Manager will manage the Sheriff's inmate program and reentry services. This request is needed to further develop jail programs and services geared at reducing recidivism. Lesli Caldwell made a motion to approve the request. Don du Bain seconded the motion. No opposition. Motion carried (6-0).

### **Public Comments Regarding the Sheriff's Office Request:**

Robert Schussel - A Vallejo resident feels the Sheriff's request is a great idea. He expressed concerns in that the staff report was not clear regarding the role of the consultant working with the Sheriff's Office as well as Health and Social Services. In addition, he voiced concerns in that the staff report was not clear regarding the role of the Program Manager.

### **Day Reporting Center Subcommittee Update:**

Donna Robinson presented an update on the DRC subcommittee's assigned tasks. The committee met on January 24, 2013 to review Corrections Consultant Tom White's updated Framework, which included Component 7- Positive Reinforcement and Sanctions, and a name for the Service Center that would reflect the actual services being provided and align with the goals of the Center. The subcommittee requested that the CCP approve a recommendation to the BOS to accept the Service Center Framework submitted by Tom White dated February 2013, and a name change for the Service Center from the Day Reporting Center (DRC) to the Solano County Center for Positive Change (CPC). Also, the Probation Department requested the CCP approve a recommendation to the BOS for personnel, contracted services, and miscellaneous expenses related to the service centers. Lesli Caldwell made a motion to approve the request. Patrick Duterte seconded the motion. Motion carried (5-0-1). Don du Bain was absent from the vote.

### **Public Comments Regarding the DRC:**

Robert Schussel – A Vallejo resident expressed concerns regarding the language of the staff report. He stated this document did not state there would be two Service Centers (Vallejo/Fairfield). He believes the document should express the intended goal which is to have

one center in Vallejo and one in Fairfield. Also, he expressed the document does not state the specific location of the requested personnel for the centers. As a resident, Mr. Schussel asked for specific goals –one center in Vallejo and one center in Fairfield— written in the staff reports. He requested, in writing, that there will be mirrored services of the Vallejo Center in the Fairfield Center as well.

Natalia Clark – A Vallejo resident expressed her concerns regarding the current violence in Vallejo. She believes putting a Service Center in the middle of the City (near schools and Children's Wonderland) will enhance crime and fear in the downtown area. She is asking the committee not to place the Service Center in Vallejo at this time. She would like to see the experiment in Fairfield. If it works in Fairfield, then, place it in Vallejo.

Pastor Anthony Summers – A Vallejo resident expressed there is a greater hope in Vallejo than people can see. He feels we must give hope and opportunity for the citizens of Vallejo, who are already in the city. Pastor Summers' business has experienced more success in the last three (3) years, than in 29 years. This is due to businesses investing in the city. He would like to encourage the committee to bring the services to Vallejo, where the services are needed the most.

Nathan Stout – A Vallejo resident made reference to Supervisor Hannigan's report to the City Council. He says she did not mention the Supervisors' response to the Council's Resolution regarding the DRC. His question is: Will the CCP respond or is it up to the BOS to respond to the City's Resolution? If there could be an official response, this would be very good.

BJ Conrad - A Vallejo resident voiced her concerns as she is waiting to hear if there is going to be an on-going cycle of parolees who come to our community. She is concerned about the successful recidivism rate, which she believes to be between 2% and 15%. She feels between 98% and 85% of the Parolees who participate in the program will recidivate. Her questions are: Will there be an annual group of people coming into the City of Vallejo going through this program? Will these people be settling in Vallejo so that we go from whatever our current level of troublemakers to an additional 20% more each year? How often will this happen?

There was a clarification from Chief Hansen: Parolees are not under supervision of the Probation Department. Parolees are under the jurisdiction of CDCR. PRCS is under Probation's purview. In addition, there are no statistics on the PRCS population regarding rates of recidivism.

### **Employment/Education/Housing Subcommittee Update:**

Stephan Betz presented an update on the Employment/Education/Housing subcommittee's meeting on January 17, 2013. At that meeting, the committee discussed the 7-point employment framework, the \$250,000 allocation for an employment pilot project, and authorization for the Chair to interview applicants for the project. Based on the discussions and recommendations, the Employment/Education/Housing subcommittee requested the CCP approve a recommendation to the BOS for funding, not to exceed \$250,000 for employment/vocational/training services; and direct the Chair of the CCP to convene a panel to

review local proposals for such services and/or pursue formal Request for Proposals or Request for Qualifications. The placement of the funding will be determined before the recommendation is presented before the Board. Patrick Duterte made a motion to approval the request. Tom Ferrara seconded the motion. No opposition. Motioned carried (6-0).

### Public Comments Regarding the Employment/Education/Housing Subcommittee:

Robert Schussel – A Vallejo resident voiced his concerns regarding the panel to review local proposals for services. He would like to see members on the committee who are familiar with the job component. He urges the committee to put together a task force to enhance future coordination.

Doug Darling – A Vallejo resident stated he appreciates the committee looking for others outside the committee to be involved on the panel. In addition, he believes Vallejo residents are concerned about families, property and lives. Also he inquired about Parolees living in Section 8/low-income housing units? He would like to join the Housing Committee as well.

Raymond Courtemanche – As the Chief Program Officer for Mission Solano, Mr. Courtemanche indicated that Mission Solano has had the privilege of serving this population (Parolees). The mission has had tremendous success working with people with a criminal history. He believes it is important to have entities such as Fighting Back, Mission Solano, and Genesis House at the table when reviewing the proposals. In addition, he would love to bring his experience to the table.

### **Probation Department Request Update:**

The Probation Department requested the CCP to approve a recommendation to the BOS to approve a contract extension for Corrections Consultant Tom White, for an amount not to exceed \$125,000, through December 31, 2014, and for Corrections Consultant Richard Crawford, for an amount not to exceed \$24,000 through December 31, 2013. Mr. White will continue to support the CCP and assist in updating the Solano County Public Safety Realignment Plan. Mr. Crawford will assist with Community Forum Meetings and will assist the Probation Department in revising the pre-sentence report format to align with Evidence Based Practices. Patrick Duterte made a motion to approve the request. Lesli Caldwell seconded the motion. No opposition. Motion carried (6-0).

## **Public Comments Regarding the Probation Department's Request:**

Robert Schussel – A Vallejo resident requested clarity in the language in the staff report regarding the responsibilities/tasks given to the consultant.

The next meeting is scheduled for Wednesday, <u>March 13, 2013 from 1:00 p.m. – 2:45 p.m.</u> at the <u>County Administration Center</u>, 675 Texas Street, Multi-Purpose Rm 1600-1620 (1<sup>st</sup> Floor).




# Bench Warrants Ordered vs. Cleared

# Bench Warrants for PRCS That FTA from CDCR







## Risk Level for Recidivism (as determined by LS/CMI tool)










## Risk Level for Recidivism by City





## Risk Level for Recidivism by City





## PRCS Profile (Ethnicity) February 2013








## PRCS Profile (Gender)





October 1<sup>st</sup>, 2011 – March 7<sup>th</sup>, 2013







ACQUITTAL: a judgment of a court, based either on the verdict of a jury or a judicial officer, that the defendant is not guilty of the offense(s) for which he or she was tried.

ADJUDICATION: the formal hearing and settling of a case by judicial procedure.

ADULT: a person 18 years of age or older.

ARREST: "... taking a person into custody, in a case and in the manner authorized by law. An arrest may be made by a peace officer or by a private person" (California Penal Code section 834).

ARREST RATE: the number of arrests per 100,000 population.

AVERAGE DAILY JAIL POPULATION: the average number of inmates housed in a local facility per day. The number includes inmates housed in single cells, double cells, dormitories (multiple occupancy cells), disabled housing, disciplinary segregation, and administrative segregation. The values reported are based upon each facility's "early morning" count.

CALIFORNIA DEPARTMENT OF CORRECTIONS AND REHABILITATION (CDCR): the state agency that operates all state adult prisons and juvenile facilities, oversees a variety of community correctional facilities and other important correctional facility responsibilities, and supervises all adult and juvenile parolees during their reentry into society.

CASELOAD: the total number of clients or cases on probation or under supervision with a given agency.

COMMUNITY CORRECTIONS PARTNERSHIP (CCP): The Community Corrections Partnership (CCP) was statutorily created as a result of the 2011 Public Safety Realignment legislation. The overall objective of the CCP is to reduce the recidivism rate of adult offenders in the local criminal justice system while ensuring that public safety is not adversely compromised. Membership in this planning and advisory body is prescribed in the enabling realignment legislation, and includes the Chief Probation Officer, the Presiding Judge of the Superior Court, a County Supervisor or County Administrator, the District Attorney, the Public Defender, the Sheriff, the Director of Health and Social Services, the County Superintendent of Education, a local chief of police, a community-based organization with experience in successfully providing rehabilitative services to persons convicted of criminal offenses, and an individual who represents the interests of victims.

CHARGE: a formal allegation that a specific person has committed a specific offense.

CITATION: a written order, issued by the police for a violation, to appear before a magistrate or probation officer at a later date.

CLEARANCE: an offense is "cleared by arrest" or solved for crime reporting purposes when at least one person is arrested, charged with the commission of an offense, and turned over to a court for prosecution. Although no physical arrest is made, a clearance by arrest can be claimed

when an offender is a person under 18 years of age and is cited to appear in juvenile court or before other juvenile authorities. An offense can also be "cleared exceptionally" for crime reporting purposes when an investigation has definitely established the identity of an offender; enough information exists to support an arrest; and the exact location of an offender is known but, for some reason, law enforcement cannot take the offender into custody.

CLEARANCE RATE: method used to determine the percentage of crimes cleared. The rate is based on the number of crimes reported.

COMMITMENT: a warrant, order, or process by which the court directs a judicial officer to take a person to a correctional facility.

COMPLAINT: a verified written accusation, filed by a prosecuting attorney with a local criminal court, which charges one or more persons with the commission of one or more offenses.

CONVICTION: a judgment, based either on the verdict of a jury or a judicial officer or on the guilty plea of the defendant, that the defendant is guilty.

CORRECTIONS: those agencies or facilities concerned with the custody, confinement, supervision, or treatment of alleged or adjudicated offenders.

COURT: an agency of the judicial branch of government authorized or established by statute or constitution, having one or more judicial officers on its staff. A court has the authority to decide upon controversies in law and disputed matters of fact brought before it. Because of court consolidation there is no longer a distinction between lower court and superior court.

CRIME: ". . . an act committed or omitted in violation of a law forbidding or commanding it. . ." (California Penal Code section 15).

CRIME RATE: the number of reported crimes per 100,000 general population.

CRIMINAL COMMITMENT: a type of commitment that results when a defendant is sentenced to an adult prison or juvenile facility overseen by the California Department of Corrections and Rehabilitation.

DEFENDANT: a person against whom a criminal proceeding is pending.

DEFERRED PAROLE REVOCATION: action taken by a prosecutor to revoke the parole status of an offender to return the subject to state prison in lieu of filing new charges.

DELINQUENT ACTS: those acts described under Welfare and Institutions Code section 602 that involve violations by a juvenile of any law or ordinance defining crime, or the violation of a court order of the juvenile court.

DISMISSAL: a decision by a judicial officer to terminate a case without a determination of guilt or innocence.

DISPOSITION – COURT: an action taken as the result of an appearance in court by a defendant. Examples are: adults – dismissed, acquitted, or convicted and sentenced; juveniles – dismissed, transferred, remanded to adult court, placed on probation, or sentenced to a CDCR youth facility.

DISPOSITION – LAW ENFORCEMENT: an action taken as the result of an arrest. Examples of police dispositions are: adults - released by law enforcement, referred to another jurisdiction, or a misdemeanor or felony complaint sought; juveniles - handled within the department, referred to another agency, or referred to the probation department or juvenile court.

DISPOSITION – PROSECUTOR: an action taken as the result of complaints requested by the arresting agency. Dispositions include granting a misdemeanor or a felony complaint, or denying a complaint for such reasons as lack of corpus, lack of sufficient evidence, interest of justice, complainant refuses to testify, witness unavailable, inadmissible search, deferred parole revocation, pre-filing deferral, and other.

DIVERSION: a disposition of a criminal defendant either before adjudication or following adjudication but prior to sentencing, in which the court directs the defendant to participate in a work, educational, or rehabilitation program.

DIVERSION DISMISSED: criminal charges dismissed after the successful completion of a diversion program.

FELONY: a crime that is punishable with death or by imprisonment in the state prison (California Penal Code sections 17 and 18).

FILING: a document filed with the court clerk by a prosecuting attorney alleging that a person committed or attempted to commit a crime.

FINE: the penalty imposed upon a convicted person by a court requiring the payment of a specified sum of money.

GRANT: the act of placing an adult on probation.

HIGH RISK SEX OFFENDER (HRSO): An HRSO is a sex offender who is required to register pursuant to PC Section 290 and has been determined to pose a higher risk to commit a new offense in the community by a risk assessment tool.

INFRACTION: an offense punishable by fine or other penalty, but not by incarceration.

JAIL: a county or city facility for incarceration of sentenced and unsentenced persons.

JURISDICTION: the territory, subject matter, or person over which lawful authority may be exercised.

JUVENILE: a person under the age of 18.

LS/CMI – LEVEL OF SERVICE / CASE MANAGEMENT INVENTORY: an assessment that measures the risk and need factors of late adolescent and adult offenders. The LS/CMI is also a fully functioning case management tool. This single application provides all the essential tools needed to aid professionals in the treatment planning and management of offenders in justice, forensic, correctional, prevention and related agencies.

LOCAL SUPERVISION: local correctional agencies provide confinement, rehabilitation, and probation services for those sentenced to their care and also house persons awaiting trial or sentencing.

MENTALLY DISORDERED OFFENDER (MDO): The Board of Prison Terms can impose mental health treatment as a condition of parole when it finds that the inmate/parolee meets the following criteria, pursuant to PC 2962:

- 1. The prisoner has a severe mental disorder; \*
- 2. The prisoner used force or violence or caused serious bodily injury in one of the prisoner's commitment crimes;
- 3. The severe mental disorder was one of the causes of or was an aggravating factor in the commission of the crime for which the prisoner was sentenced to prison; \*
- 4. The prisoner's "severe mental disorder is not in remission" or "cannot be kept in remission without treatment" \*
- 5. The prisoner had been *in treatment for the severe mental disorder for ninety (90) days* or more within the year prior to the prisoner's parole or release; and
- 6. As a result of the severe mental disorder, the prisoner represents a "substantial danger of physical harm to others".

MISDEMEANOR: a crime punishable by imprisonment in a county jail for up to one year.

NON-NON-NON (3N)/POST-RELEASE (COUNTY-LEVEL) COMMUNITY SUPERVISION (PRCS): PC Section 3450 provides that CDCR continues to have jurisdiction over all offenders who are on state parole prior to the implementation date of October 1, 2011. Prospectively, county-level supervision for offenders upon release from prison will include current non-violent, current non-serious (irrespective of priors), and some sex offenders. County-level supervision will **NOT** include:

- Inmates paroled from life terms to include third-strike offenders;
- Offenders whose current commitment offense is violent or serious, as defined by California's Penal Code §§ 667.5(c) and 1192.7(c);
- High-risk sex offenders, as defined by CDCR;
- Mentally Disordered Offenders; nor
- Offenders on parole prior to October 1, 2011.

OFFENSE: the charged offense is the crime for which the defendant was arrested or filed on by the district attorney. The convicted offense is the offense the defendant was convicted of or pleaded guilty to in court. The sustained offense is the offense for which the juvenile court sustains a petition.

PAROLE: an added period of control following release from prison (California Penal Code section 3000(a)).

PAROLE VIOLATION: violation of one or more of the conditions of parole or an illegal act for which parole is revoked rather than proceeding with criminal prosecution. See Deferred Parole Revocation.

PC (PENAL CODE): the California Penal Code contains statutes that define criminal offenses and specify corresponding punishments along with criminal justice system mandates and procedures.

PETITION TO REVOKE PROBATION: action taken by a prosecutor to revoke the probation status of an offender to return the subject to county jail or state prison.

POST-RELEASE (COUNTY-LEVEL) COMMUNITY SUPERVISION (PRCS): see NON-NON-NON (3N)

PRE-FILING DEFERRAL: action taken by a prosecutor to defer the filing of felony charges against a first-time offender who committed a less serious felony. A case is filed but there is no further disposition until the subject completes a diversionary program (e.g., support group, rehabilitation program).

PRISON: a state correctional facility where persons are confined following conviction for a felony offense.

PROBATION: a judicial requirement that a person fulfill certain conditions of behavior in lieu of a sentence to confinement. See Straight Probation.

PROBATION WITH JAIL: a type of disposition given upon conviction that imposes a jail term as a condition of probation.

PROPERTY OFFENSES: felony arrest offenses for crimes against property. This category includes burglary; theft; motor vehicle theft; forgery, check, and access card offenses; and arson.

PROSECUTOR: an attorney employed by a governmental agency whose official duty is to initiate and maintain criminal proceedings on behalf of the government against persons accused of committing criminal offenses.

PUNISHMENT: penalty imposed for wrongdoing; punishment varies by type of crime committed (see Felony, Misdemeanor, and Infraction).

RATE: a comparison of a number of events to a population.

RECIDIVISM (CPOC) DEFINITION: A subsequent criminal adjudication/conviction while on probation supervision.

RECIDIVISM (CDCR) DEFINITION: An individual convicted of a felony and incarcerated in a CDCR adult prison who was released to parole, discharged after being paroled, or directly discharged from CDCR during a defined time period and subsequently returned to prison during a specified follow-up period.

REMOVAL: a case removed from an active caseload and no longer under the supervision of the probation department or a case not removed but escalated to a more advanced level of supervision.

REVOCATION: cancellation or suspension of parole or probation.

REVOKE: to withdraw, repeal, or cancel probation or parole for an adult.

RISK LEVEL: refers to the probability of reoffending. A low-risk offender is one with a relatively low probability of reoffending (few risk factors), while a high-risk offender has a high probability (many risk factors). The LS/CMI is an assessment that measures the risk and need factors of late adolescent and adult offenders.

SENTENCE: the penalty imposed by a court upon a convicted person.

STATE INSTITUTION: a facility for housing defendants who are under the jurisdiction of state correctional or treatment programs.

STATE SUPERVISION: the state correctional system provides confinement, rehabilitation, and parole services. The principal provider of these services for adults is the California Department of Corrections and Rehabilitation (CDCR), which includes the California Rehabilitation Center (CRC). Based on special circumstances, some adult offenders are placed in the CDCR's youth facilities and the California Department of Mental Health.

STRAIGHT PROBATION: probation granted to adults without condition or stipulation that the defendant serve time in jail as a condition of probation.

SUBSEQUENT DISPOSITION: a judicial decision or sentence given at the time of a court return.

SUBSEQUENT GRANT: a subsequent grant of probation in the same court for an adult still on probation for the initial grant.

SUSTAINED: to affirm or approve as when an appellate court sustains the decision of a lower court.

SWORN PERSONNEL: a full-time employee of a law enforcement agency who has sworn to carry out law enforcement duties and has full arrest powers.

TERMINATED: satisfactorily completed specified term of probation.

UNIFORM CRIME REPORTING (UCR): a federal reporting system that provides crime data based on police statistics submitted by law enforcement agencies throughout the nation. The DOJ administers and forwards the data for California to the federal program.

3056 PC - STATE PRISONER ON PAROLE (PAROLEE)- Prisoners on parole shall remain under the supervision of the department but shall not be returned to prison except as provided in subdivision (b) or as provided by subdivision (c) of Section 3000.09. A parolee awaiting a parole revocation hearing may be housed in a county jail while awaiting revocation proceedings. If a parolee is housed in a county jail, he or she shall be housed in the county in which he or she was arrested or the county in which a petition to revoke parole has been filed or, if there is no county jail in that county, in the housing facility with which that county has contracted to house jail inmates.

1170(h) PC: Allows a judge to split the sentence of any person sentenced to prison for defendants sentenced after October 1, 2011. When a sentence is split, part of the sentence is served in custody and part of the sentence is served outside of custody on probation. For the part that is served in custody, a defendant will usually receive "day for day" credit for good behavior. However, any part of the sentence that is served out of custody must be served in full. A defendant will only receive actual time credit for any part of the sentence that is served out of custody. It is the judge's discretion as to how much time will be served in custody and how much time will be served out of custody. Penal Code section 1170(h) does not require split sentences, but gives the judge authority to allow the entire sentenced to be served in custody.
