NOTICE TO CONTRACTORS

ANNUAL PRE-QUALIFICATION OF CONTRACTORS BY SOLANO COUNTY UNDER THE CALIFORNA UNIFORM PUBLIC CONSTRUCTION COST ACCOUNTING ACT

NOTICE IS GIVEN THAT SOLANO COUNTY, CALIFORNIA, is inviting all interested licensed contractors to submit their company for inclusion on the County's Informal Bidding Contractors' List for calendar year 2017.

- 1. On October 8, 2013, the Solano County Board of Supervisors adopted a Resolution establishing the California Uniform Construction Cost Accounting Act (CUCCAA) and Informal Bidding Procedures as administered under the State Controller's Office. The Informal Bidding Procedures allow the County to create a prequalified contractors' bidder list by January 1st of each new year for public construction projects. A contractor must resubmit a new request in order to be included each new year even if that contractor has submitted a request in prior years.
- 2. Per California Public Contract Code section 22032, any public construction project that is estimated to be \$175,000 or less is subject to the Informal Bidding Procedures set forth by the State of California Uniform Construction Cost Accounting Commission. All trade categories are subject to Informal Bidding Procedures.
- 3. Contractors that have registered on the Informal Bidders' List will be notified about the County's public construction projects valued at less than \$175,000. Project notification will include a general project description, location of where to obtain more detailed information, and the time and place of bid submission at least fourteen (14) calendar days in advance of the submission deadline and bid opening.
- 4. Contractors that are interested in being on Solano County's Informal Bidders' List are required to have a current license, to be listed with the Department of Industrial Relations (DIR) in accordance with Senate Bill 854, and subject to verification through the Contractors State Licensing Board and DIR.
- 5. To register for the Informal Bidders' List, complete the form, "Request to Be Included in Solano County's Bidders' List for Notification of Informal Bids" at:

When completing the form, provide correct and accurate addresses, e-mail addresses, and/or fax numbers, and specify the type of contractor's license. Businesses that do not have accurate contact information or that fail to specify the type of work they are licensed to perform may not be notified when a project is let to informal bidding.
