PURPOSE STATEMENT – Community Corrections Partnership

The mission of the Community Corrections Partnership (CCP) is to discuss issues related to the implementation of various pieces of state legislation that focus on adult criminal offenders, including the realignment of many state public safety functions to local jurisdictions. The overall objective is to reduce the recidivism rate of adult offenders in the local criminal justice system.

Membership of the CCP is outlined in California Penal Code section 1230 and defined by the Community Corrections Performance Incentive Act of 2009 (SB 678) and includes the Chief Probation Officer (Chair)*, Presiding Judge of the Superior Court* or his or her designee, a County Supervisor or County Administrator, District Attorney*, Public Defender*, Sheriff*, the head of the Department of Social Services*, the head of the County Department of Mental Health, the head of the County Department of Employment, the head of the County Alcohol and Substance Abuse programs, the County Superintendent of Education, a local chief of police*, a representative of a community-based organization with experience in successfully providing rehabilitative services to persons convicted of criminal offenses, and an individual who represents the interests of victims.

Through AB 109/AB117 the CCP is responsible for recommending a local plan to the county Board of Supervisors (BOS) for the implementation of public safety realignment. This legislation also established an Executive Committee within the CCP. Each Executive Committee member is identified with an asterisk (*) above. The Executive Committee is responsible for approving the local plan for recommendation to the BOS.

This agenda shall be made available upon request in alternative formats to persons with a disability, as required by the Americans with Disabilities Act of 1990 (42 U.S.C. § 12132) and the Ralph M. Brown Act (Govt. Code, § 54954.2). Chief Hansen welcomed everyone and thanked them for coming.

Approval of Agenda

The motion to approve the agenda was approved.

Public Comment: No Public Comment

Approval of Minutes

The motion to approve the minutes was approved.

Council of Reentry Solutions

The Committee received an update on the Council of Reentry Solutions and was asked to consider a recommendation to allow the Council of Reentry Solutions to be affiliated with the CCP, and to provide updates to the CCP regarding the state of reentry across County departments.

The motion of Lissette Estrella-Henderson to approve the recommendation was seconded by Deanna Allen and adopted by the following vote: 10 (ten) in favor, 0 (zero) opposing and 1 (one) abstaining.

2011 Public Safety Realignment Plan Update

The Committee received information related to the requirement to update the Solano County 2011 Public Safety Realignment Plan, and was asked to consider a recommendation to hire a consultant, at a cost not to exceed \$7000, to review data, meet with stakeholders, and update the County plan.

The motion of Marla Stuart to approve the recommendation was seconded by Deanna Allen and adopted by the following vote: 11 (eleven) in favor, 0 (zero) opposing and 0 (zero) abstaining.

Budget Update

The AB 109 Adopted Budget for FY2020/21 includes appropriations of \$13 million, which includes an estimated State base allocation of \$12.7 million (including backfill funding from the State) and available unspent carryover of \$3.3 million for total estimated available funds of \$16 million. This does not include the subaccount and planning grant allocation. Because the growth allocation is applied retroactively, the lack of growth in FY2019/20 impacts FY2020/21. No growth allocation expected in FY2020/21, which will impact FY2021/22. Staff will continue to closely monitor the State Budget and sales tax/VLF revenues to determine if any additional adjustments need to be made through the Mid-Year Budget process.

Beyond the Arc Data Presentation

Chief Hansen gave a presentation on the data collected within Solano County Probation, augmented by data from the California Department of Justice (DOJ). Over a five-year period, the existing data indicates a 19% reduction in the probationer two-year reconviction rate for all grant types. Over a four-year period, the data reflects a 16% reduction in the probationer three-year reconviction rate for all grant types.

Over a five-year period, data reflects a 47% two-year reconviction rate reduction for very high risk probationers, and a 41% reduction for high risk probationers. Medium risk probationers two-year reconviction rates were reduced by 19%, and the lowest risk probationers were reduced by 18% over the same five-year period. Over a four-year period, data reflects a 16% three-year reconviction rate reduction for very high risk probationers, and a 20% reduction for high risk probationers. Medium risk probationers three-year reconviction rate were reduced by 17%, and the lowest probationers risk were reduced by 18% over the same four-year period.

Additional data continues to be collected and analyzed to provide further information on the factors both internal and external to the Solano County Probation Department that have been instrumental in the continuing reductions in probationer reconviction rates.

Employment & Eligibility Presentation

Deputy Director of Employment and Eligibility, Marla Stuart, gave a brief overview of the programs and services that Employment and Eligibility has to offer to provide economic supports so that individuals and families can live healthy, safe, and secure lives. Services geared specifically for re-entering populations include CalWORKs, and Medi-Cal.

SOAR Presentation

The Committee received a presentation on the Student Overcoming Adversity and Recidivism (SOAR) program. SOAR is a program for formerly incarcerated students at Solano Community College. SOAR provides academic and career pathways for formerly incarcerated students with the intent of graduating more students who complete degrees and certificates, transfer to four year universities and find fulfilling careers. SOAR seeks to improve the quality of life for formerly incarcerated individuals and their families, erode the stigma associated with those impacted by the criminal justice system, create safer communities and fight mass incarceration.
