Seven Suspects Arrested in Narcotics Investigation Solano County Sheriff's Office

June 30, 2011

A 3-month investigation and sales of drugs to undercover investigators resulted in the arrest of 7 people and the seizure of illegal drugs, guns and money. Detectives from the Solano County Narcotics Enforcement Team and the California Multi-Jurisdictional Methamphetamine Enforcement Team investigated the case with the assistance of the Vallejo Police Department's Major Crimes Unit, the Fairfield Police Department's Gang and Narcotics Units and the Northern California Computer Crimes Task Force.

On June 29, 2011, search warrants were served at 5 separate locations in Vallejo looking for evidence related to the investigation. One warrant was served at a residence located in the 600 block of Amador Street in Vallejo. Jesus Villasenor, a 42-year-old Vallejo resident was contacted at the scene and taken into custody for possession of methamphetamine for sale as well as possessing a stolen firearm. Another warrant was served at a vehicle storage yard located on the 1900 block of Broadway in Vallejo.

Dedicated to Community Service

Manuel Barrera, a 53-year-old Vallejo resident was taken into custody for being a felon in possession of a firearm and ammunition. Thomas Delemo, a 45-year-old Vallejo resident was taken into custody for an outstanding arrest warrant charging him with assault with a deadly weapon. A third search warrant was served at a hotel located on the 4300 block of Sonoma Blvd. in Vallejo. Gaspar Govea, a 43-year-old Vallejo resident was contacted at the scene and arrested for transportation of methamphetamine for sale and conspiracy to sell methamphetamine. A fourth search warrant was served at a residence located on the 10 block of Garford Alley in Vallejo. Kirby Bedgood, a 58-year-old Vallejo resident was arrested at the location and charged with possession of methamphetamine. A fifth search warrant was served at a storage locker that was rented from a storage facility located on the 4300 block of Sonoma Blvd. in Vallejo.

Lorenza Deluna, a 39-year-old Vallejo resident and Rodolfo Chavez, a 21-year-old Vallejo resident were also arrested on the 700 block of Admiral Callaghan for transportation and sales of methamphetamine. All of the suspects were booked into the Solano County Jail on the indicated charges. A total of approximately 1 pound of methamphetamine, 2 firearms, and \$1246 in U.S. currency were seized during this investigation.
