Agenda Item No. 23 Funds for Contracted Services

The Board was provided with an Agenda Submittal from Resource Management dated May 10, 2005, incorporated herein by reference, requesting the Board of approve an Appropriations Transfer to allow the use of funds collected from property owners for Reserved Water Service Connections to cover increased operational expenditures in electrical costs paid by Cal Water as well as the cost of the Election and for retaining consultants in Other Professional Services to conduct water quality assessments.

At the conclusion of discussion, the Board approved an Appropriations Transfer Request increase in the amount of \$110,200 to cover increases in Contracted Services of \$19,200 and Other Professional Services for \$91,000.
