SOLANO COUNTY PARK AND RECREATION COMMISSION

MINUTES OF THE REGULAR MEETING, HELD THURSDAY, July 14, 2005 AT THE COUNTY ADMINISTRATION CENTE FLOOR HEARING ROOM, LOCATED AT 675 TEXAS STREET IN THE CITY OF FAIRFIELD

Commission members present: Alvarez, Hermsmeyer, Leong, Riddle

Commission members absent: None (one vacancy)

Staff present: Norris

- 1. The meeting was called to order at 5:34 PM by Chair Hermsmeyer.
- 2. Roll Call: A quorum was confirmed. Commission member Alvarez arrived after item 3.
- 3. Approval of Minutes: On call of Chair Hermsmeyer, Commissioner Leong made a motion to approve the M the May 12, 2005 meeting as written. The motion was seconded by Commissioner Riddle and approved by a unar
- 4. Approval of Agenda: No changes were noted, however Chair Hermsmeyer reserved the option to adjust th of items on the agenda to accommodate time restraints of those present as the meeting progressed. Item 8. A. w subsequently addressed after item 4.
- 5. Chair Announcements: Chair Hermsmeyer described the recent "Bridge to Beach; A Path with a View" wor tremendous planning contribution by the volunteer efforts of design professionals and community members. Cour Rio Vista have made good progress on their planning goals as a result. Norris noted that Commissioners can join County park sites with the Board of Supervisors scheduled for Wednesday, July 27, 2005 starting at 11:30 am. Commissioners Leong and Riddle said they would attend and Eva Laevastu said she would also attend.
- 6. Commissioner and Staff Comments: Norris informed the Commission that Master Plan updates for Lake Sc Sandy Beach Parks have been approved by the appropriate Federal landowner agencies (with a letter of confirmal Army and another letter pending from the Bureau of Reclamation). Norris stated that the National Park Service is the title transfer for the Mt. Vaca property. He advised the Commission that they can expect to have a lead in corpublic hearings for planning the recreational reuse of the site. Adjacent property owners and stakeholder agencies organizations will be invited to actively participate. Environmental reviews will coincide with the site planning. Not the Commission on the inclusion of \$65,000 in the 2005-2006 FY Parks budget by the Board of Supervisors to aid master planning for the three properties acquired by the Solano Land Trust from P.G. &E. What further County co be made to the management of the Lynch Canyon property is still being negotiated.
- 7. Public Comments: No comments were provided.
- 8. Presentations/Updates/Actions:
- A. On a motion of Leong and a second from Alvarez the Commission unanimously authorized distribution of a

for the next cycle of the Fish & Wildlife grant awards consistent with the following adopted Schedule:

- July 14, 2005 Authorize distribution of applications.
- September 1, 2005 -- Closing date for applications to be submitted.
- September 8, 2005 Confirm acceptance of applications/initial review of qualified applicants.
- October 2005 Either a Special meeting or subcommittee for further review of applications, as needed.
- November 17, 2005 Presentations by qualified applicants to the Commission as a public hearing.
- January 12, 2006 Recommendations by the Commission to the Board

Norris noted that there is no timeline established yet for deposit of additional amounts to the Fish and Wildlife Furmitigation from the Kinder/Morgan case settlement. County Council advice seems to indicate that statutory authordispensing of the mitigation pay out will be pretty straightforward when the time comes. It is appropriate that the Commission keeps the existing program on schedule. Another schedule can be devised for awards of the mitigatic

B. Beverly Heintz and Valerie Williams of the Tobacco Prevention & Education Program updated the Commiss outreach efforts the coalition have made to restrict tobacco use in public parks. They noted the example of Vacav where they encountered no real public opposition. They are still building a committee on a County-wide basis and conducted initial litter surveys in the regional parks. It was noted that most cigarette litter is deposited around fir This survey will set a baseline to compare to in six months after an ordinance has been passed to see how effective restriction has become. Alvarez asked about model ordinances and available funding for the program. Ordinance still under consideration. Proposition 99 funds are down, so there is a greater reliance on the work of volunteers t and conduct surveys. Hermsmeyer wanted to confirm that there are still Proposition 99 funds available for classroeducation. It was noted that a 100% restriction on smoking in campsites may not be realistic. Riddle agrees that locations could be the stumbling block to effective enforcement by the Rangers. Many campers regard their camp home away from home and expect to be able to light up. Further talk followed regarding the baseline data collect appropriate fitting of an ordinance and guidelines to the situation. Once their committee work is further along Bev Valerie will come back to the Commission with a fuller presentation.

Leong noted the presence of Eva Laevastu who had served with him and Alvarez on the Commission before and is apparent replacement for the current vacancy. The Commissioners spoke positively about this prospect. Hermsmarked good about the accomplishments of the Commission and how things are happening for the future of County

The Commissioners confirmed that the next regular meeting will be on September 8, 2005 at 5:30 PM. The follow meeting will then be on November 17, 2005.

Adjournment: Commissioner Hermsmeyer adjourned the meeting at 6:53 PM.
