

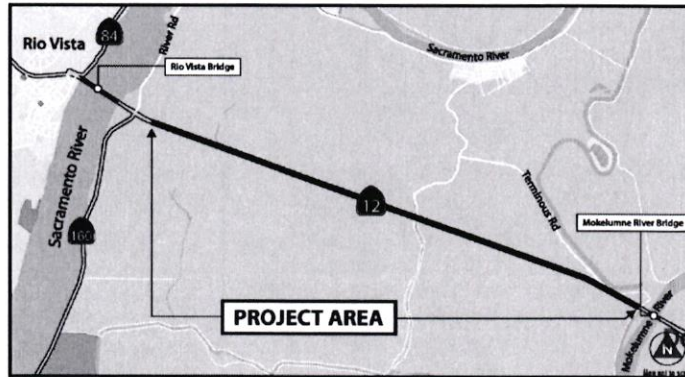


PUBLIC NOTICE

NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION FOR SAC 12 TERMINOUS SAFETY PROJECT

WHAT IS PLANNED:

The California Department of Transportation (Caltrans) proposes the Sac 12 Terminus Safety Project along State Route (SR) 12 in Sacramento County between Post Mile 0.70 (0.1 mile east of the SR 160 Junction) to Post Mile 6.11 (Mokelumne River Bridge No. 29-0043). The project proposes to install concrete median barrier, provide standard width inside shoulders, improve left turn access at the intersection of Terminus Road, grind and overlay the existing pavement, replace fair condition drainage systems, replace existing nonstandard/poor condition roadside signs, upgrade existing nonstandard guardrails, provide concrete vegetation control under guardrail, add Maintenance Vehicle Pullouts, and install a census station and closed circuit television.
