## 2024 BENEFITS SUMMARY

### UNIT 11

#### Physicians, Psychiatrists, and Dentists

*Note: County contributions and benefits listed within this document are effective for the 2024 calendar year.*

*Part-time employees working at least 20 hours per week are eligible to participate in the County's benefits plans. Contributions are prorated based on the full-time equivalency.*

*This is only a summary of benefits. Benefits are governed by the Personnel and Salary Resolution, any applicable collective bargaining agreement, or the plan documents issued by the carrier or provider. Benefits are subject to change.*

## PAY AND TIME OFF

At Solano County, all employees are paid on a bi-weekly basis on Friday. We have a direct deposit program, which all employees are required to participate in.

The following are mandated deductions from employees' paychecks:

- **State Disability Insurance (SDI):** Employees are required to pay the full cost, which is currently 1.1%.
- **Social Security Taxes:** Employees are required to pay into Social Security. This system requires contribution by both the employee (6.2%) and employer (6.2%) based on employee's earnings, to a maximum of \$168,600 per year.
- **Medicare Taxes:** All employees pay into Medicare. Currently, there are federally mandated contributions for both the employee (1.45%) and the employer (1.45%) based on employee's earnings.

Solano County wants to provide the best benefits for employees, which includes time off and a work life balance.

### HOLIDAYS

The County offers 12 full-fixed paid holidays per year:

- January 1 – New Year's Day
- The third Monday in January – Martin Luther King, Jr.'s, Birthday
- February 12 - Lincoln's Birthday
- The third Monday in February - Washington's Birthday
- The last Monday in May - Memorial Day
- July 4 - Independence Day
- The first Monday in September - Labor Day
- The second Monday in October - Indigenous Peoples' Day
- November 11 - Veterans' Day
- Thanksgiving Day – 4th Thursday in November
- Friday - the day after Thanksgiving Day
- December 25 - Christmas Day

Additionally, the County offers two (2) partial-fixed paid holidays per year where employees are provided four (4) hours of holiday pay to supplement their workday:

- December 24 – Christmas Eve
- December 31 – New Year's Eve

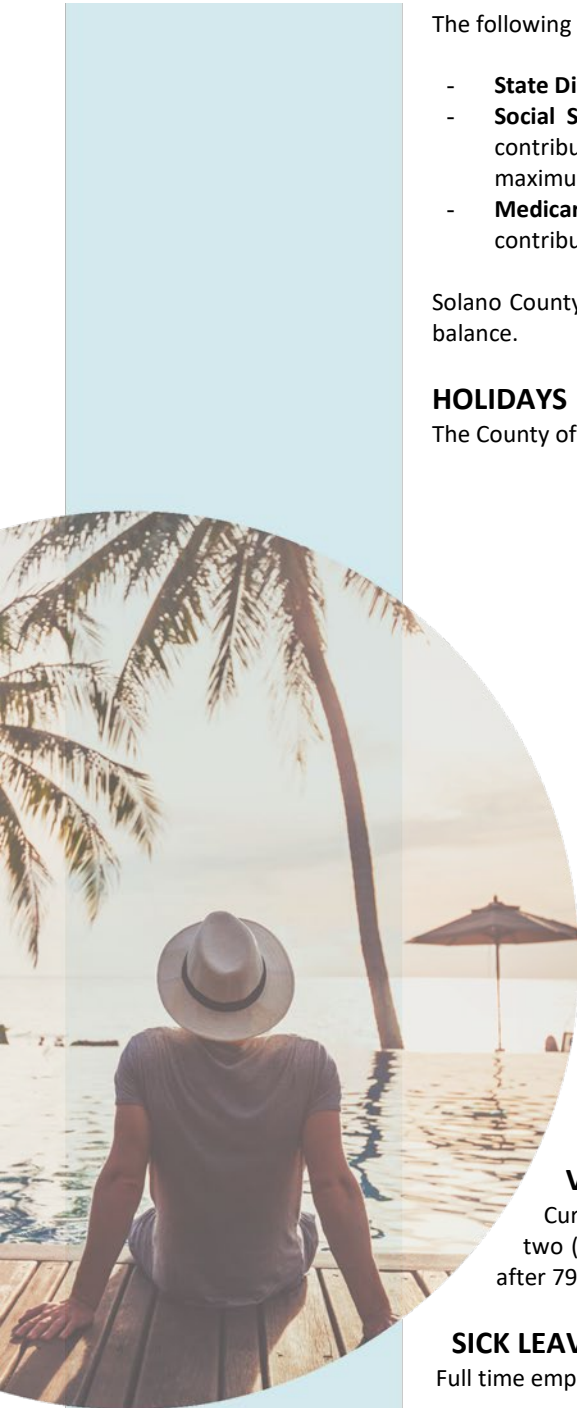
Employees in this unit are also provided an additional one (1) Floating Holiday per year that may be used at any time during the calendar year.

### VACATION

Currently, employees in this unit start accruing 3.08 hours per pay period which is equivalent to two (2) full weeks of time off accrued per year. This rate increases to 4.62 hours per pay period after 79 full-time pay periods and 6.16 hours per pay period after 260 full-time pay periods.

### SICK LEAVE

Full time employees earn 3.70 hours per pay period. There is no limit on the maximum Sick Leave Accrual.

# MEDICAL, VISION, DENTAL, & LIFE INSURANCE

Solano County offers options for Medical, Vision, Dental, and Life insurance all of which are effective the first of the month following date of hire. For additional information regarding the type of insurance provided, please refer to the resources page (see QR code at the end of the summary).



### MEDICAL INSURANCE

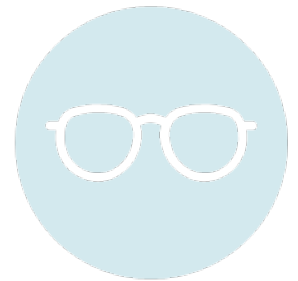
Solano County offers a wide range of choices through CalPERS health program. The maximum County contribution for family coverage for the 2024 calendar year is \$2,124.54 per month. If the medical plan costs are less than \$2,124.54 per month, employees will receive the difference as taxable earnings to a maximum of \$334.58.

Employees enrolled in employee plus two or more coverage receive a \$50.00 per month supplemental County contribution into the cafeteria plan.

Employees who waive CalPERS medical coverage due to alternate group medical insurance are eligible to receive a taxable earnings equivalent to \$500 less the CalPERS Minimum Employer Contribution (\$343.00 per month for 2024 calendar year).

### VISION INSURANCE

The County pays for the standard Vision Plan which is \$12.40 per month, per employee and employees have the option to purchase an enhanced vision plan for an additional cost of \$9.82 per month.



### DENTAL INSURANCE

Employees have two Dental Plan options with the County paying 100% of the cost. The County pays a maximum of \$98.30 per month per employee for the 2024 calendar year.

### LIFE INSURANCE

Solano County offers life insurance at 1.5 times the employee's base yearly earnings to a maximum of \$350,000. Life insurance is paid by the County at a cost of \$0.142 per \$1,000 of coverage. Employees may purchase supplemental life insurance up to three times the employee's base yearly earnings to a maximum of \$500,000 and \$250,000 for spouses with cost based on age.



# RETIREMENT

## CalPERS PENSION

This position is covered by a pension program provided by the State of California Public Employees' Retirement System (PERS). Employees will be enrolled in one of the following benefit formulas based on eligibility:

Employees who have never been a member of any public retirement system prior to January 1, 2013, or who have moved between retirement systems and were not subject to reciprocity, or who have moved between public employers within a public retirement system after a break in service that is greater than six months are eligible for a miscellaneous retirement plan of the **2% at age 62** benefit formula. The employee contribution rate for the **2% at age 62** benefit is 7.5%, all of which is paid by the employee as a pre-tax deduction.

Employees entering membership in Solano County's miscellaneous retirement plan on or after May 4, 2012 but before January 1, 2013, or who have moved between public employers within a public retirement system with a break in service that is less than six months are eligible for a **2% at age 60** benefit formula. The employee contribution rate for the **2% at age 60** benefit is 7%, all of which is paid by the employee as a pre-tax deduction.

Employees entering membership in Solano County's miscellaneous retirement plan prior to May 4, 2012 are eligible for a **2.7% at age 55** benefit formula. The employee contribution rate for the **2.7% at age 55** benefit is 8%, all of which is paid by the employee as a pre-tax deduction.

The employer rate for Fiscal Year 2023/2024 is 28.74%.

For Fiscal Year 2024/2025, the employer rate is scheduled to increase to 31.60%.

## DEFERRED COMPENSATION

### 457(b) Plan

All regular and limited term employees are eligible to participate in a 457(b) plan provided through Nationwide. The County contributes a dollar-for-dollar match to a maximum of \$50 per pay period. The 2024 normal maximum yearly total contribution is \$23,000; employees age 50 or older may contribute an additional \$7,500 per year.

### 401(a) Plan

Within sixty (60) calendar days from their date of hire, regular and limited term employees are eligible to make a one-time irrevocable election to participate in a 401(a) plan administered by Nationwide. The 401(a) plan provisions require mandatory employee contributions of 0%, 2%, 5%, 7.5%, 10%, 12.5%, 15%, 17.5%, 20%, 22.5%, or 25%.

## RETIREE HEALTH

The County offers a personal retirement health savings plan. Upon retirement from the County, 100% of accumulated unused sick leave accruals will be paid tax-free into this account. Money in the account may only be used for health care-related expenses eligible under Internal Revenue Code, Section 213.

## OTHER BENEFITS

Not only does Solano County provide the great benefits already mentioned, we also provide a wide variety of additional benefits



### FLEXIBLE SPENDING ACCOUNTS

The County offers three different Flexible Spending Accounts for Health Care Reimbursement, Dependent Care Reimbursement, and Transportation Expenses. Employees have the option to set aside funds on a pre-tax basis to cover qualified expenses.



### LONGEVITY PAY

Employees are eligible to receive an additional 2.5% longevity pay, per level, after the completion of continuous service at 10, 20, 25, 30 and 35 years.

### EMPLOYEE ASSISTANCE PROGRAM (EAP)

The County provides an Employee Assistance Program through Anthem for employees and their eligible dependents. The EAP provides up to five free, confidential counseling sessions per incident for employee and/or eligible dependent(s) per fiscal year. The County pays 100% of the premium, which is \$1.50 per month, per employee.



### CONTINUING EDUCATION ALLOWANCE

Up to 50 hours per fiscal year to participate in continuing education courses required for licensing as accepted by the appropriate state board. Each July, employees receive a cash payment of \$3,000 to partially offset tuition and/or registration fees and the cost of course related materials for continuing education requirements. Employees who start County employment after July 1st, shall receive within the employee's first two full paychecks following date of hire, the pro-rata amount based on the number of full pay periods remaining in the fiscal year from the date of hire. ### MOVING AND RELOCATION ALLOWANCE

A maximum \$3,000 moving and relocation expense allowance, plus up to \$3,000 reimbursement for moving expenses is available for newly hired employees, subject to approval by the County Administrator. Additionally, up to \$5,000 reimbursement for moving expenses for extended family (parents/in-laws) after minimum one year employment with the County.

### RECRUITMENT BONUS

Subject to approval by the County Administrator, newly hired, Clinic Physicians and Clinic Physicians (Board Certified) not employed with Partnership Healthplan of California network may receive a \$30,000 stipend for a 12-month minimum employment commitment. Additionally, subject to approval by the County Administrator, newly hired, Psychiatrists, Psychiatrists (Board Certified) and Psychiatrists (Child-Board Certified) may receive a \$30,000 stipend for a 24-month minimum employment commitment.

### STUDENT LOAN REPAYMENT PROGRAM

Solano County participates in the California State Loan Repayment Program for up to ten (10) new full-time applicant employees. Please refer to the applicable MOU for program details. The County may also participate in the student loan repayment program offered by the County Medical Services Program ("CMSP").
