August 12, 2016 Designated by Elect. Office E - 88	Deadline to Submit Resolutions for Local Measures:
	Last day for resolutions calling measures to be submitted to the elections official. Ed. C. §5322, EC §§9401, 9500
August 16, 2016 Designated by Elect. Office E - 84	Deadline for Submitting Impartial Analyses:
	Impartial Analysis prepared by County Counsel for County/Schools and City Attorney for Cities. EC §§ 9160, 9280, 9313, 9500
August 19, 2016 Designated by Elect. Office E - 81	Deadline for Submitting Direct Arguments:
	Direct arguments for and against the measure are to be submitted by this date. EC §§ 9163, 9316, 9502
August 19 – August 29, 2016 E - 81 to E - 71	10-Day Public Exam Period for Direct Arguments and Analyses:
	Period of public examination of proposed direct arguments (if any). EC §9509
August 29, 2016 Designated by Elect. Office E - 71	Deadline for Submitting Rebuttal Arguments:
	Rebuttal arguments by the authors of the direct arguments are to be submitted by this date. EC §§ 9167, 9504(a)(b), 9600
August 30 – September 8, 2016 E - 71 to E - 61	10-Day Public Exam Period for Rebuttal Arguments:
	Period of public examination of proposed Rebuttal arguments (if any). EC §9509
September 9, 2016 E - 60	Election Official's Deadline for Submission of Local Measure Information to Printer:
	Completion of submission of ballot/sample ballot order to printer by County Elections Official.
November 1, 2016 E - 7	Publication of Notice of Measures to be Voted on at Municipal Election:
	The city elections official shall publish a synopsis of the measure at least one time not later than one week before the election in a newspaper of general circulation in the city. EC § 12111

NOTE: The final date for the County Elections Official to have submitted all copies to the printer, as quoted on the above calendar, is firm.

IMPORTANT NOTE FOR CITIES: Cities are responsible for the publication of the "Notice of Election" for their measures and the publication of the "Notice to Submit Arguments"; the receiving and processing of direct arguments/rebuttal arguments; and the preparation of the Impartial Analysis. Due to cities consolidating with the county under EC 10400, the above dates will be used for deadlines regarding arguments, rebuttals and the 10-day viewing periods.
