## **Call to Order**

The meeting was called to order at 3:00 p.m.

Introductions: Chief Hansen welcomed members and requested introductions.

## **Approval of Agenda**

Sheriff Stanton made a motion to approve the agenda. The motion was seconded by Judge Beeman. No opposition. Motion carried.

## **Approval of Minutes**

Judge Beeman made a motion to approve the minutes. The motion was seconded by Don du Bain. No opposition. Motion carried

## **Public Comment**

An opportunity was provided for members of the public to address the committee on matters not listed on the Agenda. No comments.

## **Data Report** *(See Handout- PowerPoint) – Sheriff’s Office Data April 11, 2012*

The Sheriff’s Office presented a PowerPoint presentation regarding statistical information pertaining to the realignment population which is being tracked by the Sheriff’s Office.

- Jail Population: 831
- Parolees: 182
- 1170(h) (N3’s): 110 in custody represents 13.2 of jail population
- 3455 PC Violators: 17 in custody represents 2.0% of jail population
- Average Length of Stay: Pre AB109-19.7 days; Post AB109- 21.7 days

Chief Deputy Probation Officer Donna Robinson presented a PowerPoint Presentation of the data collected beginning October 1, 2011 through March 31, 2012. *(See Handout - PowerPoint) - Probation Data*

- 374 Packets received
- 252 Required to report to Probation
- 50 BW ordered; 21 warrants cleared
- 88 % Reporting as directed; 12% Failed to report
- Cities w/highest PRCS: Vallejo 37 %; Fairfield 34%; Vacaville 18%; Benicia, Rio vista, Dixon, Suisun 11 %
- Risk Level: Very High 12 %; High 55 %; Medium 16%; Low 1%
- Identified Criminogenic Needs: Substance Abuse Treatment and Mental Health Treatment

**Data Subcommittee Report - Realignment Data - (See Handouts) – Community Corrections Partnership Sheriff's Office**  
*Memo – CCP Data Collection Meeting – Local AB109 Info Sharing Efforts*

Capt. Gary Elliott reported the subcommittee has been focused on two objectives:

- Identifying what information is being collected from the various agencies (Sheriff's Office, Probation , DA, H&SS, PD) and determining what information is missing
- Understanding how the agencies communicate with each other and how information is shared with local law enforcement and other stakeholders

Capt. Elliott also presented a summary memo from Carol Cain that highlighted the SharePoint Server. This project is progressing.

**Substance Abuse/Mental Health Subcommittee Report - (See Handouts)**

Patrick Duterte reviewed the short-term and long- term plans. Halsey Simmons continues to work with Probation to ensure proper services.

The survey is completed and being reviewed. A total of 160 surveys were sent out with 63 responses received.

**DRC Subcommittee Report and Request – (See Handouts) RFP Request for the Day Reporting Center in Solano County**  
*Day Reporting Center Scope of Services*

The DRC Subcommittee Workgroup (Donna Robinson, Stephan Betz, Halsey Simmons, and Ron Grassi) met with Karen Poole from General Services to discuss the RFP process. There was discussion regarding the RFP process and how to proceed. It was determined that additional information should be gathered and reviewed prior to initiating a RFP for a Day Reporting Center.

Stephan Betz suggested that the Workgroup develop a profile of the PRCS population (age, city of residence, number of felony convictions, criminogenic needs, etc.) and use this information to develop a scope of work and statement of purpose. This information will be presented to the CCP for further discussion.

Patrick Duterte made a motion for the DRC Workgroup to move forward on developing the DRC Scope of Work and provide results to the CCP.

Lesli Caldwell seconded the motion. No opposition. Motion carried.

**Budget Report and Request – (See Handout) Memo – Public Safety Realignment (AB109) Budget Report**

Ron Grassi reported the California State Association of Counties (CSAC) is working to establish an allocation formula for FY2012/13.

The proposal for FY2012/13 is summarized in the Public Safety Realignment (AB109) Requested Budget. Based on the funding allocation, the committee must be cognizant of spending priorities. There was a discussion regarding the projected funding for FY2012/13 as well as the remaining funds for FY2011/12.

Chief Hansen stated the Additional Funding Requests will be tabled until next month's meeting. This will allow departments to review their budget requests and expenditures.
