Comments, Questions & Answers:

- 1. The Board suggested working with the local National Alliance on Mental Illness (NAMI) to help educate the community on the legal and jail system with respect to mental illness.
- 2. How do your groups interface and how do people join; how does the community become aware of these programs? The Solano County Mental Health Wellness and Recovery program offers concurrent client groups and family support groups by trained staff and trained peer providers. There is no preregistration necessary to attend the groups; it is a drop-in participation program. Flyers and posters are located in County Mental Health Clinics. Board Members asked for copies of flyers to distribute at outreach events.
- 3. How do you get around privacy issues? The talk is in general terms what most clients' experience.

# V. DIRECTOR/COMMITTEE REPORTS Behavioral Health Program Report:

**Halsey Simmons**, Behavioral Health Director, provided an update on Local, State and Federal Mental Health Services to include updates regarding:

- Bill AB403: Foster Youth Continuum of Care Reform and its possible budgetary impact to Solano County Mental Health.
  - The Board recommends using resources for the provision and training of foster care.
- The Mental Health Services Act Senior Manager position is filled; Tracy Lacey introduced.
- Mental Health and Substance Abuse programs are working diligently with Information Technology (IT) to develop and utilize performance systems tools. More to report as systems develop.
- Solano County Mental Health received a \$2 Million grant (SB-82) for a Crisis Residential Facility and County officials are currently looking at facility options. Bay Area Community Services (BACS) was awarded the contract to operate services and is currently using a property called Rosewood House in Vallejo.
- Mental Health has a contract with Heather House in conjunction with the Caminar Home Program.

**Sandra Sinz**, Mental Health Services Administrator provided an update on Quality Improvement and Adult System of Care:

 Ms. Sinz is working on a volunteer peer support work program that will be utilized in County Mental Health clinics.
