File with the Clerk of the Board of Supervisors the original Board Agenda and copies of all districts board resolutions requesting consolidation with the election.	July 27th
Board of Supervisors Meeting:	
Meeting of the Board of Supervisors to approve the request for consolidation with the election.	August 9th
Publications-Notice of Election & Notice to Submit Arguments:	
Publication of Notice of Election by County Elections. Publication for submission of direct arguments for and against the measure. Ed. C. §§ 5363, 15120; EC §12111; GC §§ 6060, 6061	July 11 – August 10 E-120 – E-90
Early date to submit resolutions and measure text to the elections official. Suggested Date EC §9502	July 20th E-111 Designated by Elect. Office
Last day for resolutions calling measures to be submitted to the elections official Ed. C. §5322, EC § §9401, 9500	August 12th E-88
Period for Submitting Direct Arguments:	
Direct arguments for and against the measure are to be submitted by this date. EC §9502	August 19th E-81 Designated by Elect. Office
Preparation of Impartial Analysis:	
Impartial Analysis prepared by County Counsel for County/Schools and City Attorney for Cities EC §9500	August 29th E-71
Period for Submitting Rebuttal Arguments:	
Rebuttal arguments by the authors of the direct arguments are to be submitted by this date. EC §§9504, 9600	August 29th E-71 Designated by Elect. Office
10-Day Public Exam Period:	
Period of public examination of proposed measure, analysis and arguments (if any).EC §9509	August 29 – September 8 E-71 – E-61
Election Official's Deadline for Submission of Local Measures Information to Printer:	
Completion of submission of ballot/sample ballot order to printer by County Elections Official	Date based on agreement between Elections office & the Printer

The dates beginning with the publication date may adjust by a few days earlier or later than the quoted date, affecting the events that follow by a few days. **To verify the dates call the County Elections Office** at (707) 784-3351 or (707) 784-6675.

The final date for the County Elections Official to submit all copies to the printer, will be firm.

IMPORTANT NOTE FOR CITIES: Cities are responsible for the publication of the "Notice of Election" for their measures and the publication of the "Notice to Submit Arguments"; the receiving and processing of direct arguments/rebuttal arguments; the preparation of the Impartial Analyses and the 10-Day Public Examination Period. Due to this fact the cities' deadline for requesting consolidation with the election is the 88th day prior to Election Day. The last scheduled Board of Supervisors meeting prior to the 88th day is **August 9th**. The deadline for submitting the cities resolution requesting consolidation with the Clerk of the Board of Supervisors for the **August 9th** meeting is **July 26th**. The City must submit a calendar of events and deadlines to the Elections Office.
