## **Shooting Investigation Leads to Two Arrests**

On March 16, 2012, at approximately 3:30 PM, deputies from the Solano County Sheriff's Office responded to the area of Hay Road and Dally Road after receiving a report of shots being fired in the area. Deputies arrived to learn that 2 suspects in a white Cadillac were firing rounds off from inside the vehicle as they drove up and down the roadway. A witness was able to provide a license plate on the vehicle and a broadcast was put out to surrounding law enforcement agencies to be on the lookout for that vehicle. According to witness statements, nobody was injured during the course of the shooting.

Later that evening at approximately 11:30 PM, the Sheriff's Office received a report from the Vacaville Police Department that the suspect vehicle involved in the earlier shooting was found parked in a driveway of a residence located on the 500 block of Isabelle Drive in Vacaville. Deputies responded to the residence and with the assistance of Vacaville Police Officers, located 19-year-old Armando Tinocoduran who admitted to driving the vehicle earlier in the day. A search of the suspect vehicle resulted in the discovery of a loaded .357 Magnum revolver, ammunition for the .357 Magnum as well as other caliber guns. Spent shell casings were also discovered inside the vehicle. During an interview with the suspect, he admitted to shooting rounds off with his gun in the area of the shooting reported earlier in the day. He also reported the identity of a second suspect that was with him during the time the shooting occurred.

Tincoduran was arrested and booked into the Solano County Jail on a variety of charges including shooting at an inhabited dwelling, discharging a firearm from a vehicle, and carrying a concealed firearm in a vehicle. His bail was set at \$60,000.

On March 17, 2012, at approximately 10:30 AM, deputies conducted follow-up investigation on this case at a residence located on the 100 block of Goldenroad Court in Vacaville. Deputies located 21-year-old Eric Alejandro Camerena, who was identified as the second suspect riding in the vehicle that was involved in the shooting the day prior. Camerena admitted to being in the vehicle at the time of the shooting, but denied shooting at any dwelling. A 22 caliber semi-automatic handgun was seized from his residence along with ammunition that matched the type seized in the vehicle that was reportedly used during the commission of the crime. He was taken into custody and booked in the Solano County Jail for shooting at an inhabited dwelling, carrying a concealed firearm in a vehicle, and possession of a loaded firearm in a vehicle. His bail has been set at \$60,000.
