## **PROJECT LOCATION:** Solano County Fairgrounds, 900 Fairgrounds Drive, APN 0052-240-550, 560

**PROJECT DESCRIPTION:** The County of Solano, in collaboration with the Solano County Fair Board Association and the City of Vallejo, has developed the Solano360 Specific Plan, a long-term plan for redevelopment of the Solano County Fairgrounds. The Specific Plan establishes land uses and a comprehensive set of infrastructure and development standards for the property while retaining the ability to respond to market conditions and opportunities for private development. The proposed General Plan and Zoning Amendments are required for plan consistency; the Development Agreement provides assurance to both the City and County that the project may proceed in accordance with existing policies, rules and regulations and subject to specific processes and oversight; and the Tentative Map provides design improvements of the land to facilitate leasing and financing for future development projects, and certain conditions of approval.

## **ENVIRONMENTAL DETERMINATION:** Pursuant to the California Environmental Quality Act (CEQA), an Environmental Impact Report (EIR) for the project was prepared, circulated for public review and certified by the Solano County Board of Supervisors on February 26, 2013.
