## Implementation of New Rules Regarding Overtime for IHSS Homecare Workers

The Solano County IHSS Public Authority is currently recruiting caregivers for the Registry.

Effective January 1, 2015, new rules go into effect to allow IHSS caregivers to receive overtime for hours worked above 40 per workweek. California State Department of Social Services will be sending all IHSS recipients and providers notices in November. These notices tell you that you are required to complete some new forms and return them to the County by December 15, 2014. There will also be new timesheets beginning January 1, 2015. To help you better understand all these new rules, how to complete the new forms and timesheets, the County is offering some information sessions to assist you. You will find the dates, times, and locations of these sessions, along with information on where to return forms on the inside of this newsletter.

## Implementacion de Reglas de Sobre Horas para Proveedores de Servicios De Apoyo en el Hogar (IHSS)

Efectivo el 1 de Enero del 2015, entran nuevas reglas permitiendo a proveedores de IHSS a recibir pago de sobre horas por trabajar más de 40 horas semanales. El Departamento de Salud y Servicios Humanos del Estado de California enviara avisos a todos los clientes/consumidores y proveedores de IHSS este Noviembre. Este aviso les informara que necesita completar nuevos formularios y enviarlos al Condado nomas tardar del 15 de Diciembre del 2014. Con estas nuevas reglas las hojas de tiempo cambiaran empezando el 1 de Enero del 2015. Para asistirlos en mejor entender las nuevas reglas, las hojas de tiempo, y como completar los formularios, el Condado está ofreciendo varias sesiones informativas. 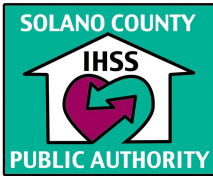
