SUBJECT: Major Thoroughfare Area of Benefit No.1

The Board of Supervisors adopted an ordinance No.80-88 on June 13, 1980, creating the Major Thoroughfare Area of Benefit No.1 Fee. The area of benefit includes Green Valley, Rockville, Suisun Valley areas of the County. The ordinance established a road impact fee prior to construction of a new residential dwelling or any subdivision of land that creates a residential parcel. The fee is not collected on property that is zoned agricultural. Refer to the ordinance for specifics on when and where the fee is collected. Effective July 1, 1980, the fee was originally established at \$2,504. In accordance with the resolution, the fee shall be adjusted each year on January 1 and July 1 by the percentage change in the Engineering News Record (ENR) Construction Cost Index.

ENR Index as of July 1, 1980 = 3198

ENR Index as of January 1, 2025 = 13731

Major Thoroughfare Area of Benefit No.1

(January 1st thru June 30th, 2025) $\frac{13731}{3198} \times \$2,504 = \mathbf{\$10,751.00}$

Exception 1: Green Valley Highlands III (Developer paid \$500.00 per parcel on July 1, 1980). The remaining balance for Green Valley Highlands III is **\$10,251.00**.

Exception 2: Middle Green Valley Area has been amended and separated by the Development Agreement recorded on April 4, 2015, as Document No. 201500029542. The document reestablished the fee based on the ENR Index in April 2015.

The said fee shall be reevaluated in April 2025 as described in the agreement. From thereon, the fee is shall be adjusted monthly. Please see said document for the particulars.

ENR Index as of April 2015	=	9992
Sample ENR Index as of October 1, 2023	=	13497.97
*Major Thoroughfare Area of Benefit No.1 (Monthly change of Fee based on ENR Index)	=	$\frac{13497.97}{9992} \times \$2,504 =$ \$10,568.77
