

CORONAVIRUS UPDATE #13 (06/05/2020)

Hello Benicia, Fairfield and Vallejo,

Welcome to my most recent coronavirus update. As I write to you, our county is facing challenging times. While facing the coronavirus crisis, the death of George Floyd has once again brought forward the unfortunate reality that we have serious inequities in this country. George Floyd's death was wrong, and it breaks my heart to think of how his life was taken.

I am in full support of peaceful protests that have been occurring in our community. This past weekend, I was present for a rally at the steps of Vallejo city hall and a student led rally in Benicia. I was so proud of our community for coming together to protest injustice. Protesting injustice is at the core of who we are as a nation.

However, the destruction we have seen (separate from the peaceful protests) hurts our community. Small businesses were particularly hit hard by the damage. The Sheriff, working with local agencies and the state, issued the curfew to protect the community. The city of Vallejo issued its own curfew before the county's.

I attended a press conference with Congressmember Mike Thompson, Supervisor Erin Hannigan, Vallejo Mayor Bob Sampayan, all the Vallejo City Councilmembers, Vallejo City Manager Greg Nyhoff and Vallejo Police Chief Shawny Williams where information was presented on the curfew as well as the need to address inequities in our society.

Congressmember Mike Thompson stated that he would be introducing legislation in Congress to reform police departments in the United States. Specifically, he announced legislation that will keep data on police officers fired for misconduct, so they do not get hired in other jurisdictions. I support these and other reform efforts aimed at stopping inequitable treatment. I will be sending a letter to our state representatives asking for needed police reforms at the state level.

George Floyd's death is a painful reminder that our nation has a long way to go to fulfill our promise of equal treatment under the law. George Floyd deserves justice and we must raise our voices peacefully to bring needed changes to our society.

CURFEWS ENDED, EMERGENCY STILL IN PLACE

Both Solano County and the city of Vallejo have ended their curfews while keeping an emergency declaration in effect. Both jurisdictions are monitoring events as they happen. Both jurisdictions have made it clear that if the situation warrants, the Sheriff and/or the city of Vallejo have the authority to reinstitute the curfew.

CORONAVIRUS TESTING IN SOLANO COUNTY

Solano County has two sites for testing, one in Vallejo and one in Vacaville. The Vacaville site will likely move to Fairfield next week. We need to show community demand for these sites in order to keep them. I encourage everyone to get tested for Covid-19.

Testing is one of the key components to successfully reopening our community. It will help us determine when numbers are rising, who we need to contact for possible exposure and shows us who has coronavirus without symptoms (allowing them to take appropriate measures).

While the increase is consistent with the rates we have seen, it is always difficult to announce that we have lost residents to Covid-19. This update is dedicated to the memory of our most recent Covid-19 fatalities. My heart goes out to their families. Please honor their memory by doing everything we can to stop the spread of this virus.
