MINUTES

The Solano County Board of Supervisors met on the 6th day of September, 2005 in regular session in the Chambers of the Board of Supervisors of the County of Solano in the Solano County Government Center, 675 Texas Street, Fairfield, California at 8:32 A.M. pursuant to County Code Section 2-1.103. Present were Supervisors Kromm, Reagan, Silva, Vasquez, and Chairwoman Kondylis. Also present were Michael D. Johnson, County Administrator and Dennis Bunting, County Counsel. Michael D. Johnson left the meeting at 9:20 a.m.

Agenda Item No. 3 Closed Session

The Board of Supervisors recessed this meeting at 8:33 a.m. to convene in Closed Session on the following matters:

The Chairwoman invited individuals of the public to make statements on matters relating to the business of the Solano County Board of Supervisors. The following individuals made public comments:

- A) Supervisor Vasquez announced that Solano County was the recipient of additional awards at the California State Fair which included: 1) Manager's Award; 2) People's Choice Award Most Educational; and 4) People's Choice Award Most Fun.
- B) Greg Coppes, American Legion, requested the County's assistance in repair to the roof at the Veterans' Building in Dixon. Chairwoman Kondylis requested that General Services provide a staff report to the Board on this matter on September 13, 2005. It was noted that the County would be working with the Dixon Redevelopment Agency to review future long term rehabilitation of the Dixon Veterans Building.
- C) Donald Tipton, unincorporated Vallejo, expressed concern regarding the parking garage, security, and health and safety of employees at the County Government Center.
- D) Supervisor Reagan commented on the U.S. Air Force Tops and Blues concert held at the County Government Center on September 3, 2005 and thanked County staff for their assistance.
- E) Supervisor Reagan acknowledged the dedicated personnel from Travis Air Force Base who have responded to the gulf area to open air fields and roads to allow supplies to reach the flood victims of Hurricane Katrina.
- F) Supervisor Reagan expressed his gratitude to the Solano County Parks and Recreation Commission for their efforts in establishing a memorial at Sandy Beach Park to honor the life-long contributions of Michael "Mick" Freese.
- G) Supervisor Silva noted that fundraising efforts were underway with the County's healthcare partners in their effort to insure 100 percent of the children in Solano County and encouraged business leaders to participate.
- H) Supervisor Kromm requested that this meeting of the Board of Supervisors be adjourned in memory of Lt. Col. Rex W. Floyd, original founder of the JROTC program at Fairfield High School in 1968 and dedicated community volunteer.

Agenda Item No. 22 Local Disease Prevention Project

The Board introduced and waived full reading of an Ordinance adding Chapter 13.1 Sections 13.1-10 through 13.1-40 relating to the implementation of a Local Disease Prevention Project to prevent the spread of HIV, hepatitis and other blood-borne diseases among injection drug users, their partners and their children.

At the conclusion of a public hearing to consider an ordinance adding Chapter 13.1 Sections 13.1-10 through 13.1-40 relating to the implementation of a Local Disease Prevention Project to prevent the spread of HIV, hepatitis and other blood-borne diseases among injection drug users, their partners and their children. The Board amended the proposed ordinance to include a sunset date of December 31, 2010 and directed staff to provide an annual report to the Board indicating how many clean needles were sold, and how many new cases of HIV and hepatitis were discovered in Solano County. The Board set September 27, 2005 for adoption of the proposed ordinance.

(Supervisor Reagan did not support the unmonitored purchase of needles by illegal drug users, preferring interventions by medical professionals to reduce self and societally destructive behaviors.) (Supervisor Silva expressed his concern that the staff report did not adequately address costs, law enforcement, counseling and treatment services, and that the program was not endorsed by the federal government nationwide.)

Authorized the Director of Resource Management to negotiate agreements with the Solano Transportation Authority and other affected parties regarding Federal Transportation Earmark Funds for the Turner Parkway Overcrossing in Vallejo and for improvements to various access roads to Travis Air Force Base.
