**READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THE STATEMENT. FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.**

1. We have determined that your vote-by-mail envelope (or provisional envelope) is either missing a signature or does not match the signature on file in your voter record.
2. In order to ensure that your vote-by-mail (or provisional) ballot will be counted, the Unsigned Ballot/Signature Verification Statement should be completed and returned as soon as possible so that it can reach our office no later than the date indicated on the statement.
3. You must sign your name where specified on the Statement (Voter's Signature).
4. You must return the form by the date indicated by one of the following methods:
