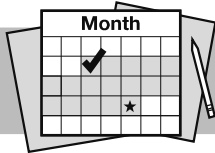



VOTING OPTIONS FOR ALL VOTERS

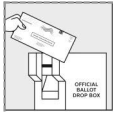


In an effort to reduce the impact of the Coronavirus spread, the Solano County Registrar of Voters has prepared several voting options for all voters. You have received a vote-by-mail ballot for the election in this packet.

Below is a description of the different options you have for voting new to help provide a safe voting environment for all voters, our staff, and our community partners:

No Contact Voting:

As an option to in-person voting, all voters can vote from the safety of your home, using the enclosed ballot. Ballots can be returned to our office in one of three manners:



Ballot Drop-Off:

Starting October 5 (29 days) - 15 Drop-Off locations are available (drop box is inside an office building).



Curbside Drop-Off:

Starting October 29 (5 days) - 10 Curbside drop-off locations are available (stay in your car, hand ballot to pollworkers)



Election Day Drop-Off:

Election Day November 3 (1 day) - 100 poll place drop-off locations are available on Election day- all locations are open 7am to 8pm.

All ballots must be received or post-marked by November 3. All postage is paid by the Registrar of Voters Office for voters mailing ballots back to our office. Voters do not have to vote this ballot, and can still choose to vote in-person using one of the options listed below.

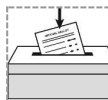
Limited Contact Voting:



At your assigned poll place, all voters can request to vote "Curb-Side" from the comfort of your vehicle. Look for the blue cone outside of your polling place, and call the number listed on the cone. Pollworkers will come out to your car with your ballot and will securely deposit it for you.

This same curb-side option is available if you want to drop off your vote by mail ballot. It may be preferable for you to remain in your vehicle and we support that option.

In-Person Voting:



Traditional poll place are still available. Your assigned location is included on the cover sheet with your official ballot. Some voters may experience additional wait times due to the need to provide social distancing within the voting location. Please be prepared it may take longer than usual to vote at your polling place.

COVID-19 INFO:

Pollworkers and Staff:

All poll workers will be required to wear masks and shields, additionally the Registrar of Voters will provide gloves, hand sanitizer, and disinfecting wipes.

Voters:

Voters will be required to wear face coverings as required by state law. Face coverings will be provided to any voter needing one. Hand Sanitizer and disposable pens will be provided to all voters. Voters without face coverings will be encouraged to vote from the safety of their vehicles, or when the pollworkers can clear the area for the safety of other voters.

We encourage all citizens to follow the mandated health requirements to help protect our staff and community partners. Without our staff and volunteers we cannot successfully execute an election! Please help us minimize the risk to those helping to administer your voting rights!

**IMPARTIAL ANALYSIS OF MEASURE S
DIXON WATER RATE REPEAL INITIATIVE**

Measure S, if approved by a majority of voters, would repeal current water rates which took effect April 1, 2019. The Measure would reestablish the rates that were in effect prior to April 1, 2019, until such time as the Dixon City Council undertakes a new rate setting process. Measure S was placed on the ballot by voter initiative.

In 2014, the City of Dixon ("City") assumed ownership, operation, and maintenance of one (1) of the two (2) water systems serving the City. As a condition of the permit to operate the water system, the State Water Resources Control Board directed the City to complete a water rate study to determine the proper cost of service based on the infrastructure, operating, and maintenance needs of the water system.

The City hired a consultant to study the water system and to compose a five-year rate schedule based on the needs of the water system, as documented in the Water System Master Plan and Strategic Asset Management Plan. The City then hired a separate consultant to develop a rate study which identified operating expenses, infrastructure upgrades, and financial obligations for the water system. Based on the results of the rate study, the consultant found existing rates did not adequately fund the infrastructure, operating, and maintenance needs of the water system. The City accepted the results of the rate study and commenced proceedings to adopt a new rate schedule.

Prior to increasing water rates, state law requires that the City first provide customers an opportunity to submit written protests at a public hearing. On January 22, 2019, the City held a noticed public hearing to receive protest votes against the proposed rate increase. The City did not receive a majority protest vote and the City Council proceeded to adopt the new rate schedule as set forth in Resolution 19-010. The new rate schedule went into effect April 1, 2019, providing for a series of rate increases through 2022.

Measure S would repeal current water rates and would reinstitute the rates in effect prior to April 1, 2019. The Measure would also direct the Dixon City Council to propose a different rate schedule and to conduct a new rate setting process. Repealing current water rates, and reinstating prior rates, would also delay City efforts currently underway to address the operating and infrastructure needs identified in the consultant's rate study.

A "Yes" vote on Measure S repeals existing water rates, reinstates the rates in effect prior to April 1, 2019, and directs the City to conduct a new rate setting process.

A "No" vote on Measure S maintains the existing water rates, which became effective April 1, 2019.

FULL TEXT

THE PEOPLE OF THE CITY OF DIXON DO ORDAIN AS FOLLOWS:

SECTION I: The City Council of the City of Dixon has increased the water rates charged to the City of Dixon Water District that cannot be sustain by the ratepayers within the Water District.

SECTION II: The voters of the City of Dixon Water District desire to repeal the recent increase in accordance with Section 3 of Article XIII C of the Constitution of the State of California. Further, the people of the City of Dixon Water District desire that the City repeal these unsounded and unfair rates and call on the City to undertake a new, sincere and comprehensive look at adopting water rates that reflect the Water District's legitimate costs of providing water service without creating huge new debt obligations by the selling bonds or subsidizing future development.

Any future rate setting process should respect the participation of all ratepayers by (a) providing impartial, accurate information regarding the impact of the proposed new rates; (b) providing all ratepayers a reasonable opportunity to participate and does not effect of suppressing ratepayer/voter involvement; (c) be cognizant of the impact of any rate increase on businesses and families, particularly to the large number of fixed and low income households in this community; and (d) adopting rates that are rational and justified by the City of Dixon Water District's operational costs related to delivery of water services, and infrastructure maintenance and improvement needs.

SECTION III: In accordance with Section 3 of Article XIII C of the Constitution of the State of California, the People of the City of Dixon Water District hereby repeal the water rates adopted by the City Council on January 22, 2019. RESOLUTION 19-010 IS HEREBY REPEALED AND TO REESTABLISH THE LAWFUL WATER RATES IN EFFECT ON JANUARY 1, 2019.

SECTION IV: If any provision of this measure or the application thereof to any person or circumstances is held invalid, that invalidity shall not affect other provisions or application, and to this end the provisions of this measure are severable.

SECTION V: This measure may not be amended except upon voter approval.

A “No” vote will uphold the City’s decision to increase water rates for critical repairs and improvements to the water system. Clean water is critical to the quality of life of our residents and reliable water service is essential. We cannot afford to jeopardize the City’s water system. The existing water rates are necessary to provide safe, uncontaminated, and reliable water service. Please vote “No” on Measure S.

In 2019, the Dixon City Council approved water rate increases through 2022. The City’s wells, pumps, storage tanks, and pipes need maintenance and important upgrades so the City can deliver clean, safe, and reliable water to residents. We also need regular safety testing, adequate staffing for responsive customer service, and strong water pressure for our fire department when fires occur. The old rates no longer cover these costs.

The water rates are an investment in Dixon’s future. The new rates began in April 2019, and the largest increases have already occurred. All payments go directly toward maintaining and operating the water system. Under state law, the City cannot charge above the cost of providing service and must justify all expenses.

The legality of rolling back water rates is currently being challenged in the courts. Rolling back rates threatens water quality and dependable water service, which are essential government functions. Backtracking now would jeopardize the progress made in securing our water system. If Measure S passes, the City will have to impose the old water rates and begin the rate setting process again. This means added costs and potentially unstable and unreliable water service. Let’s move forward, not backward.

A “No” vote on Measure S means clean water and dependable service for the long haul.

In 2019 it went UP to \$1.34/cf; in 2020 UP to \$2.02/cf; and will go UP to \$2.42 in 2021 and UP to \$2.59 in 2022.

**DIXON ELECTED CITY CLERK INITIATIVE
IMPARTIAL ANALYSIS OF MEASURE T**

Measure T asks Dixon voters whether the office of City Clerk for the City of Dixon (“City”) should be an elected rather than an appointed position. Measure T was placed on the ballot by a petition signed by the requisite number of voters.

State law requires general law cities, such as the City, to have a City Clerk. A City Clerk may be appointed or elected. A majority of California cities have an appointed City Clerk. City Clerks are elected offices under state law unless city voters elect to turn the City Clerk office into an appointed position. Dixon voters made the office of the City Clerk an appointed position in 1950. The Dixon Municipal Code authorizes the City Manager to appoint the City Clerk subject to ratification by the City Council. The current City Clerk is appointed and a full-time employee with the City.

State law establishes the basic functions and duties of the City Clerk. The City Clerk administers local processes and municipal services such as elections and access to City records, ensuring that all local legislative action is properly executed, recorded, and archived. The City Clerk prepares the meeting agendas and minutes for City Council meetings as well as for other City committees and commissions, verifies legal notices have been posted or published, accepts service of claims, lawsuits and official documents on behalf of the City, manages compliance with California conflict of interest filings regulations, and performs other duties required by law.

The City has established minimum training and experience requirements to ensure that the City Clerk can perform the duties of the position. The City Manager can appoint the best qualified individual regardless of that person’s place of residence. The City Manager also conducts annual performance reviews of the City Clerk and can terminate the City Clerk at any time for unsatisfactory performance.

If Measure T passes, the City will lose the ability to establish minimum City Clerk training and experience requirements and

will not be able to terminate the City Clerk for unsatisfactory performance. An elected City Clerk can only be removed at a general election or by recall. The only requirements for an elected City Clerk position are to be at least 18 years of age, be a registered voter of the City, and be a resident of the City.

If Dixon voters approve Measure T, Measure T will require the City Council to incur the costs of a special election for the election of a new City Clerk. The City Clerk elected at the special election will serve until the City’s next general election on November 8, 2022. Subsequently, the City Clerk will be elected every 4 years. The City will bear the costs of all subsequent elections to elect the City Clerk.

A “YES” vote on Measure T will convert the office of the City Clerk to an elected position.

A “NO” vote on Measure T will leave the City Clerk as an appointed position.

MEASURE T

FULL TEXT

THE PEOPLE OF THE CITY OF DIXON DO ORDAIN AS FOLLOWS:

SECTION I: The Measure adopted at Municipal General Election held on April 11, 1950, by which the City Council shall appoint the City Clerk, is repealed.

SECTION II: Following the adoption of this Measure, the City Council shall call a special election, which may be consolidated with any other election as provided by law, to fill the office of City Clerk until the next succeeding regular Municipal General Election.

SECTION III: At the next succeeding regular Municipal General Election referenced in Section 2 of this Measure, the election for City Clerk shall be for a full four year term of office. The election of the City Clerk shall be held every four years thereafter at the time of the General Municipal election, as provided by law.

SECTION IV: Each provision of the ordinance is severable, and the invalidity of any section or part shall not affect the validity of its other provisions.

ARGUMENT IN FAVOR OF MEASURE T

YES on MEASURE T means that all of the VOTERS will ELECT the City Clerk, unlike our city council members who are elected by districts. A Yes vote will REQUIRE that this important public officer LIVE IN DIXON and be a FULL member of our community.

An appointed City Clerk does not have to live or pay taxes in Dixon.

In California, ALL City Clerks, whether elected or appointed, are offered the same professional training to become a Certified Municipal Clerk.

The current appointment process has been a DISASTER. It requires the City Clerk to serve at the pleasure of the UN-ELECTED City Manager. This has resulted in the FAILURE of the Office of the City Clerk to follow State Law, such as to guard against the disclosure of the identity of voters who petition for initiative and referendum.

Since 2010 the City Clerk's office has been a revolving door of short term, out-of-town, excessively paid persons who were under the thumb of the City Manager. One was the spouse of a partner of the City Attorney's law firm. Another was a resident of Southern California hired only to "manage" the water rate Proposition 218 protests. Others lasted only until they could acquire a letter of recommendation and be hired elsewhere.

70 years ago, by a vote of 125 to 84, Dixon allowed for the appointment of the city clerk. Now, Dixon has a much bigger population and city government; and a bigger need to guard against public corruption.

By voting YES you require that the City Clerk LIVE in Dixon and be an INDEPENDENT public servant interested serving ALL RESIDENTS while performing the important work of the office without fear or favor.

DON'T BE FOOLED INTO BELIEVING DIXON NOW MUST HAVE AN ELECTED CITY CLERK AFTER 70 YEARS OR THAT AN ELECTED CITY CLERK WILL DO A BETTER JOB.

Electing someone only ensures that the person is at least 18 years old and lives in Dixon. An elected City Clerk will likely have **NO** FORMAL TRAINING AND **NO** EXPERIENCE AS A CITY CLERK. The current APPOINTED City Clerk, who grew up and lives in Dixon, has completed the professional training and has 17 years of experience as a Dixon City Clerk's office employee.

Even if Dixon had an elected City Clerk, the City must still have a full time employee, like our current appointed Clerk, available day-to-day to make sure all of the complex, time sensitive administrative tasks of the City Clerk's Office are completed in a timely manner.

Even if Dixon had an elected City Clerk, there is no way to ensure that the inexperienced, untrained elected Clerk would not make errors. There is also no guarantee they would take 3 years of necessary training to become a Certified Municipal Clerk. If the elected City Clerk is incompetent, there are only two options to remove them: wait up to 4 years until the next election or hold a costly recall election.

Those signing this statement share the concern about the need for continuity in the City Clerk position. We do not believe politicizing the office to elect the City Clerk is the solution.

ARGUMENT AGAINST MEASURE T

All California cities must have a City Clerk. In 1950, Dixon voters wisely recognized the benefits of an “appointed” City Clerk and voted to no longer have an elected City Clerk.

The City Clerk’s job requires specialized professional training and keeping up with law changes is critical. The City Clerk is responsible for understanding and implementing State Laws relating to the Public Records Act, Brown Act, Maddy Act, Conflict of Interest and Campaign Law under the Political Reform Act and the Fair Political Practices Commission, Election Law, amongst others.

The City Clerk must be an experienced Elections Official who conducts the Municipal Elections for Mayor, City Council and for Initiative, Referendum and Recall petitions. In addition, the City Clerk is the custodian of City records, including City Council and Commission minutes, ordinances, resolutions, agreements, contracts, bonds and deeds. The City Clerk may also be responsible for supervision of staff.

It is unreasonable to expect an elected City Clerk to have or be able to quickly obtain the specialized professional skills and training necessary to do the technical job of City Clerk. Furthermore, an elected City Clerk may be unable to or be unwilling to spend the number of hours necessary to properly perform all the important duties of an effective City Clerk. Unlike an appointed City Clerk, an elected City Clerk can only be removed from office by not being re-elected every 4 years or be recalled from office by Dixon voters.

In the history of 70 years with Dixon’s appointed City Clerks, except for a few years, only 8 people have held the permanent position of appointed City Clerk. The current appointed City Clerk is a very capable 17 year City employee and a lifetime Dixon resident.

This conflicts with the duties of the City Clerk to guard the rights of residents against retaliation from City officials. In fact just last year the unelected City Manager appointed the “Assistant City Manager” to be the “temporary” City Clerk.

An elected City Clerk will allow the city clerk to perform the duties of office without interference by others in City Hall, and without the fear that she may be terminated at any time.

VOTER BILL *of* RIGHTS



You have a right to...



1. cast a ballot if you are a registered voter. You can register to vote if you are

- a U.S. citizen
- at least 18 years old
- not in prison or on parole
- registered to vote where you currently live.

2. vote on a provisional ballot if your name is not on the list of registered voters.

3. vote if you are in line when the polls close.

4. cast a secret ballot without anyone bothering you or telling you how to vote.

5. get a new ballot if you have made a mistake as long as you still have your old ballot. If you are at a polling place, ask an election official for a new ballot. If you vote by mail, you must give your original ballot to an election official before the polls close on Election Day before you can ask for a new ballot.

6. get help voting and casting your ballot.

7. the right to drop off your completed vote-by-mail ballot at any polling place.

8. get election materials in a language other than English if enough people in your voting precinct need a ballot in that language.

9. ask questions about election procedures and watch the election process. You can ask questions of election officials about procedures. The person you ask must answer your questions or send you to the right person for an answer. Please don't ask questions while election officers are busy working.

10. report anything happening in the polling place that is a crime or if you believe someone is not who they say they are.

SPECIAL NOTICE

- Polls are open from 7:00 a.m. to 8:00 p.m. on the day indicated in the posted sample ballot.
- Specific instructions on how to vote, including how to cast a provisional ballot, can be obtained from a poll worker or by reading the information mailed to you by your local elections official.
- If you are a newly registered voter, you may be asked to provide appropriate identification or other documentation according to federal law. But please note that every individual has the right to cast a provisional ballot even if he or she does not provide the documentation.
- It is against the law to represent yourself as being eligible to vote unless you meet all of the requirements to vote under federal and state law.
- It is against the law to tamper with voting equipment.

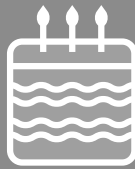

**POLLS ARE OPEN FROM 7:00 A.M.

If you are scheduled to be at work during that time and you do not have sufficient time outside of working hours to vote at a statewide election, California law allows you to take up to two hours off to vote, without losing any pay.

You may take as much time as you need to vote, but only two hours of that time will be paid.

Your time off for voting can be only at the beginning or end of your regular work shift, whichever allows the most free time for voting and the least time off from your regular working shift, unless you make another arrangement with your employer.

If three working days before the election you think you will need time off to vote, you must notify your employer at least two working days prior to the election.
