CORONAVIRUS VACCINATION

I know how difficult this pandemic has been. I know there is strong demand to get vaccinated. While we are seeing more vaccines being ordered and a more coordinated effort from Washington D.C. to get the vaccines out, we still do not have enough vaccines to vaccinate everyone currently eligible. I know I have said that previously, but I want to emphasize that demand is far outpacing supply when it comes to the vaccine.

We are currently vaccinating on a tiered approach. The tiers are available in the link below. Most of the vaccines were given to healthcare providers by the state. Kaiser alone covers 2/3 of Solano County's residents, so Kaiser received most of the vaccines. Most people in the current tiers will be vaccinated by their healthcare providers at this time.

The county is planning to open a mass vaccination site(s) for those in the eligible tiers who are not able to get vaccinated through their healthcare provider. I will provide more information on this when the details are released.

The county has created a COVID-19 vaccine interest form to see when the vaccine will be available to certain phases. That is included in the link below. You can also sign up with the state to get notified when you are eligible for the vaccine. That information is included below as well.
