Solano360 Committee September 10, 2021 1:30 P.M. Minutes

CALL TO ORDER

The Solano360 Implementation Committee met on the 10th day of September 2021 in regular session in the Board of Supervisors Chambers at the Solano County Government Center, 675 Texas Street, Fairfield, CA at 1:32 P.M. Present were Solano County Supervisor Jim Spering, City of Vallejo Councilmember Pippin Dew, City of Vallejo Mayor Robert McConnell, and Solano County Supervisor Erin Hannigan. Chairwoman Hannigan presided.

ROLL CALL

Supervisor Jim Spering, Councilmember Pippin Dew, Mayor Robert McConnell and Supervisor Erin Hannigan.

PUBLIC COMMENT

Chairwoman Hannigan invited members of the public to address the Committee on items listed on the agenda. There were no comments by the public.

APPROVAL OF THE MINUTES

On motion of Committee Member McConnell, seconded by Committee Member Spering, the Committee approved the minutes of the April 8, 2021 Solano360 Implementation Committee meeting. So ordered by a 4-0 vote

INDUSTRIAL REALTY GROUP, LLC (IRG) PRESENTATION

Assistant County Administrator Nancy Huston introduced the item and recommended action.

CRA and Placement Principal Mike Lindenlaub provided an overview of the updated IRG Solano360 Draft Plan, stating IRG has tried to maximize the benefits of what was in the Specific Plan with product that it knows is going to work on the site and in the future. Mr. Lindenlaub further stated his organization plans to begin with three site activators: a neighborhood commercial with a residential component, a maker space, and film studios with a possible backlot. Mr. Lindenlaub stated IRG's narrative is California's landscape and water features, noting they will design the site in natural settings, using the water features throughout the site to mimic components of California's water system, including bridges and streams, with educational plaques to indicate what the feature represents. Mr. Lindenlaub further stated the goal is that people will be encouraged to walk or cycle the site, creating a pedestrian friendly environment within the site.

Senior Architect Rex Capenter provided an overview of the planned housing component for the Solano360 site, noting IRG's goal is to build multiple types of housing, which will provide opportunities for economically mixed populations to create a diverse neighborhood.

President for Management Advisory Services Tom Sinclair provided an overview of the Solano360 key milestones schedule.

COMMITTEE DELIBERATION

Committee Member Spering requested staff return to the December 2021 meeting with a plans to enable the City of Vallejo and County planning staff the ability to streamline the permitting process. Committee Member Spering further stated this is a very critical piece of moving the project forward, noting he believes the Committee must take advantage of this window of opportunity and accelerating the project can provide an advantage with bringing in outside developers.

Committee Member Dew spoke in support of Committee Member Spering's recommendation, noting she would be supportive of anything that the City can do to expedite the process. Committee Member Dew requested staff and IRG return to the December 2021 meeting with more financial data to support market rate absorption, noting she would like to see what kind of price points IRG is looking at that would make it feasible to enter into the next phase?

Committee Member McConnell spoke in support of an expedited process, noting the City will need help as their planning department is down to 50%. Committee Member McConnell requested more specificity on the plan going forward, noting he would like to see some measurable time deadlines and measurable results as we move through this process.

In response to comments from the Committee, Mr. Lindenlaub stated IRG is addressing the six components of the Specific Plan while trying to bring the best economic sustainability that it can to the site which is why they presented what they have in the phasing that they have proposed.

Chairwoman Hannigan spoke in support of the project stating she is in favor of how IRG has broken down the plan into the three areas: the site, the water, the nature of pedestrian setting, noting, it isn't just all business or living, but it includes exercise, enjoyment of the water features, and participating in whatever activities that are occurring on the site. Chairwoman Hannigan requested staff return with a more in depth look at the financials of the project.

In response to comments from Chairwoman Hannigan, Ms. Huston stated the first step is to work on the land uses and once the land uses are all agreed upon, then staff can start doing the calculus on the financials.

On motion of Committee Member Spering, seconded by Committee Member Dew, the Committee endorsed Industrial Realty Group, LLC's proposed land plan and land uses on the basis for future entitlement applications and other supporting documents to implement the Solano360 project; and approved the milestone schedule for submitting and processing entitlement applications for approvals by Solano County and the City of Vallejo. So ordered by a 4-0 vote.
