**RE: SUPPORT, Extending the Affordable Connectivity Program**

Dear Representative Garamendi:

On behalf of the Solano County Board of Supervisors, I am writing to urge you to take action to extend funding for the Affordable Connectivity Program (ACP).

Enacted as part of the 2021 Infrastructure Investment and Jobs Act (P.L. 117-58), the ACP provides low-income households with a discount of up to \$30 per month for internet service and up to \$75 per month on qualifying Tribal lands or high-cost locations, making an internet subscription affordable for all – and in many cases, entirely free. In conjunction with historic State and Federal investments in broadband infrastructure and digital equity, the ACP has resulted in bridging the digital divide by closing the affordability gap in Solano County and in communities across the country.

According to the State of California's Department of Technology, 41 percent of households in Solano County are eligible for participation in the ACP. To date, nearly 20,000 households have enrolled in the program, with over 41,000 additional households eligible for participation. The ACP ensures that low-income residents of our County can gain and continue to have access to affordable, reliable, and high-quality advanced communications services. As has been clearly shown over the course of the last three years, broadband internet service is indispensable for employment, education, health care, commerce, community building, civic engagement, and government services.

Unfortunately, funding for the ACP is projected to be exhausted by April of this year. Without congressional action to extend the program, many residents of Solano County who rely on the ACP, including low-income seniors, veterans, and students, would see their internet bill increase. Moreover, in some cases, households may lose internet access altogether.

Additionally, the loss of the ACP would reduce the efficacy of the IIJA's \$42 billion investment in the Broadband Equity, Access, and Deployment (BEAD) Program, which is a key component of federal efforts aimed at ensuring that everyone in America – including individuals and families in hard-to-serve rural areas – has access to affordable, reliable high-speed internet. Pursuant to a recent study, the existence of the ACP reduces by 25 percent the per-household subsidy needed to incentivize internet service providers to build in rural areas. Indeed, sustained ACP funding is critical as broadband companies and others consider the level of public and private investment needed to fulfill Congress' goal of universal affordable broadband deployment and adoption.

In closing, Solano County urges you to ensure that long-term ACP funding is a top priority for inclusion in the final fiscal year 2024 appropriations package or another legislative vehicle. Continued investment


