IV. Public Hearing: First 5 California Annual Report

Motion: Approve the First 5 California Children and Families Commission's FY2022/23 Annual Report

[Public hearing was opened at 3:28 PM]

First 5 Solano Policy and Fund Manager Toya Adams presented the First 5 California Annual Report. Each year, Prop 10 requires the First 5 California Commission prepare an annual report on what the 58 counties statewide have been contributing to the well-being of children ages 0-5 and their families. Continuing investments include Home Visiting Coordination, Stronger Starts public education and awareness campaign, Dragon Song campaign. New investments include \$10M to strengthen the 0-5 strategy, foundational research for Fatherhood Initiative, and newly developed partnerships with the Sacramento Kings, Los Angeles Dodgers, PBS Kids amongst others. The annual report featured four result areas, including improved family resiliency, improved child development, improved child health, and improved systems of care. Ms. Adams also highlighted the F5CA inclusion of the Early Learning Center in Vallejo as a Solano County highlight.

V. First 5 Solano FY2024/25 Annual Budget

First 5 Solano Deputy Director Denise Winters presented the FY2024/25 Annual Budget. This budget will be effective July 1st, 2024 until June 30th, 2025. The budget does not include funds that are not secured. While projected revenue is considerably lower than last year, revenue generated last fiscal year is included as expenditures this coming year for the ELC, and will not be a major factor for next fiscal year.

VI. Executive Director's Report

First 5 Solano Executive Director Michele Harris gave an update on Annual Grants (grants award up to \$20k to successful applicants), indicating that there were 22 applicants who submitted a Letter of Intent and of those, 21 held a grant development session with F5S staff, and 12 ultimately applied. Ms. Harris also noted that the launch party held for the Early Learning Center was received well and that construction on the ELC will begin in May. In connection with that, F5S staff conducted a tour of the ELC for the Syar Foundation last month, aiming for a significant donation to support the building of a Community Resource Building at the ELC site. Additionally, Ms. Harris indicated that March 25th-27th F5S staff, along with Commissioner Fabi and Hannigan, will be attending First 5 California's annual summit. Ms. Harris will be a speaker at two presentations during the conference.

VII. Commissioner Remarks

Commissioner Chair Fabi announced that due to her Governor appointed spot on the First 5 California Commission, it will be necessary for her to resign from the F5S Commission. Ms. Fabi read her resignation letter to the Commission and received positive and heartfelt feedback from her fellow Commissioners, thanking her for her service and wishing her luck.

Each year, the First 5 Solano Commission elects its officers (Chair and Vice-Chair) for the next year as per its Bylaws. The Commission has a past practice of offering the chair and vice-chair officer positions to those commissioners that have joined the commission and have not yet served as an officer, and can participate for 3 years on the Policy and Oversight Committee (past chair, chair, vice chair). Based on this tenure, the two Commissioners listed above have agreed to serve as the next Chair and Vice-Chair of the Commission. The current Chair, Amy Fabi, has been appointed to the First 5 California Commission, effectively removing Amy Fabi from the First 5 Solano Commission, once a replacement has been selected for her seat on the Commission.

This item brings forward a motion to approve Neely McElroy as 2024 Chair and Lisette Estrella-Henderson as 2024 Vice-Chair of the First 5 Solano Children and Families Commission. With the appointment of Amy Fabi to the First 5 CA Commission, these officers serve a term of April 2024 – December 2024 in the position, beginning with the April Commission meeting.

Resolution No. 2024-04

RESOLUTION OF THE FIRST 5 SOLANO CHILDREN AND FAMILIES COMMISSION PROCLAIMING MAY 10, 2024 AS CHILD CARE PROVIDER APPRECIATION DAY

WHEREAS, high quality child care and early education play a crucial role in child development, health and nutrition, child abuse prevention, and social-emotional outcomes that result in enhanced school readiness, and successful K-12 educational and higher education experiences; and

WHEREAS, child care providers include teachers and caregivers in child care centers, family child care homes, extended family, friends, and neighbors, all of whom are essential to supporting working parents; and

WHEREAS, there are over 550 licensed child care providers, over 1,000 license-exempt child care providers, and countless other community members in Solano County who provide this essential service which supports the local economy; and

WHEREAS, child care programs, which are mostly small businesses, run and staffed predominantly by women, are still recovering from health and financial hardships stemming from the pandemic while they have continued to meet the needs of families; and

WHEREAS, Solano County has acknowledged the crucial role that child care plays in the local economy, resource infrastructure during emergencies, and in everyday lives of community members who count on safe and reliable child care to work, go to school, and become self-sufficient; and

WHEREAS, Solano Family and Children Services in partnership with the Solano County Workforce Development Board and Small Business Development Center, continues to engagement in a childcare provider recruitment and business development campaign with the goal of expanding the availability of licensed childcare settings prepared to serve families with strong business skills and quality childcare in Solano County;

WHEREAS, Solano Family & Children's Services, the First 5 Solano Children and Families Commission, the Local Child Care Planning Council, along with advocacy organizations across the United States, will be increasing awareness of the importance of child care providers on May 10, 2024.

NOW, THEREFORE, BE IT RESOLVED that the First 5 Solano Children and Families Commission does hereby proclaim May 10, 2024 as Child Care Provider Appreciation Day in Solano County.








Eirth Rate and Young Child Population


Number of children 0-5 in Solano County

The number of births and the birth rate have not changed significantly over the last several years, remaining at about 5,000 births and 11 births per 1,000 residents each year.






Child Population by Race/Ethnicity

Percent of children 0-5 in Solano County over time by race/ethnicity


In 2023, 37% of children 0-5 in the county were Latino, 29% were White, 13% were Asian, 12% were Black, and 8% were multicultural.

Solano County is one of the most diverse counties in California. Relative to most neighboring counties, it has a higher proportion of children who are Black and lower proportion of children who are White.







Low Birth Weight Rate

Percent of babies born low birth weight

The low-birth-weight rate held steady at 8% between 2021 and 2022. The rate remains similar to the rate in Contra Costa County but is slightly higher than the rates in Sonoma and Yolo Counties and the state overall. Low birth rate is most often caused by prematurity.




Healthy Births and Ethnicity

Percent of babies born in Solano County with risk factors, by race/ethnicity

Latina and Black people are least likely to receive timely prenatal care. A lack of prenatal care also contributes to poor birth outcomes among Black babies.

Research has shown that women of color have historically experienced institutional racism, cultural or linguistic barriers, and lack of access to quality care, which have adversely impacted their perinatal outcomes.



Well-Child Visits


Percent of children on Medi-Cal with recommended number of well-child visits, by age

Only 26% of children ages 0-15 months with Medi-Cal attended the recommended number of well-child visits in 2021. However, over half of children ages 15-30 months had a well-child visit, and the rate is only slightly lower than in nearby counties and the state.

By 2022, the percent of children ages 1-5 receiving a dental check-up had returned to pre-COVID-19 rates.



Levelopmental Screenings

Percent of children on Medi-Cal with a developmental screening in the first three years of life

In 2021, 25% of children ages 0-3 on Medi-Cal received a developmental screening, a rate lower than in other surrounding counties and the state overall.




Licensed child care slots in Solano County

Despite a significant drop in the availability of licensed care during temporary COVID-19 pandemic site closures in 2020, the number of slots actually increased between 2019 and 2021. The increase in capacity was limited to center-based settings.

The availability of child care for working parents is still lower in Solano County than in comparison counties and the state overall.




Percent of children 3-4 enrolled in preschool or TK

Third graders meeting or exceeding standards by Solano County school view by... Math district



View by... Economically Disadvantaged Thi.. Third graders meeting or exceeding standards in Solano County, by race/ethnicity and socioeconomic status


Black, Latino, and Multicultural children are less likely to be proficient than Asian, Filipino, and White children in Language Arts/Literacy and Math. For most racial/ethnic groups, this disparity is seen regardless of socioeconomic status and therefore points to other disparities such as inequitable access to quality of early care and education.




The substantiated maltreatment rate remains highest among Black children across all counties. This disparity is partly due to Black families being under-resourced relative to families of other races/ethnicities.



Motion V: Consider approval of allocations of funding for up to \$52,140 for FY2024/25 Annual Grants in response to Request for Applications #2024-01 as follows:

- a. \$12,140 to Circle of Friends to provide Conscious Discipline teacher coaching, parent education, and family activities.
- b. \$20,000 to Make it Home to expand the reach of Make it Home services to families in Solano County with children ages 5 and under to ensure that families are safe, stable and self-sufficient through providing furniture.
- c. \$20,000 to Solano County Health Equity for African American/Black Lives to provide race equity trainings for healthcare professionals serving Black babies, mothers, and families.

<u>Staff Report:</u> In FY2024/25, the Commission dedicated \$160,000 toward its seventh year of Annual Grants. These grants of up to \$20,000 were made available in Request for Applications (RFA) #2024-01 to meet a variety of community needs. In this cycle of funding, applicants were required to submit a Letter of Intent and attend a 30-minute mandatory grant development session facilitated by First 5 Solano staff. First 5 Solano received 22 Letters of Intent and 21 proposers attended a grant development session. In total,12 applications were submitted in response to the RFA. Of those applications, 8 met the minimum criteria to be considered for funding.

A review panel consisting of representatives from First 5 Solano and other experts in the area of early childhood, read and assigned preliminary scores to the 8 applications. The review panel subsequently met to finalize their scores and rankings, with the top 3 proposals presented to the Commission for funding.

Equity Initiative

The 2nd of 3 Equity Trainings was held April 9 for local leadership. The session was again well attended, with over 20 local leaders from a variety of organizations coming together to discuss Diversity, Equity and Inclusion.

Pati Navalta led the workshop by engaging the group with, "What song makes you feel pure joy?", opening each participant up to share a special memory/feeling that they have for music. The group participated in distinguishing between diversity and inclusion, watched a video titled "Brown Eyes, Blue Eyes", practiced shifting language and had several breakout sessions to discuss continuing/practicing the skills that Pati continues to provide.

First 5 California Summit: In March 2024, First 5 Solano staff attended the annual First 5 California Child Health, Education, and Care Summit. The theme of the 3-day, statewide conference was "Stronger Starts: 25 Years of First 5", where attendees focused on sharing collective knowledge around new and improved systems-change frameworks and initiatives focused on First 5 California's North Star and Audacious Goal.

Additional highlights of the summit also included a keynote address by Glen Henry, CEO of Beleaf in Fatherhood (introduced by First 5 California Commissioner, Amy Fabi). First 5 Solano was also featured in two summit workshops:

- 1. Legislative and Policy Springboard Strategies: How to cultivate the relationships necessary for success, presented by Michele Harris, First 5 Solano Executive Director in partnership with Erin Hannigan, Board of Supervisor Member and Commissioner, with ASR, the Commission's evaluation consultant leading the session.
- 2. Results Based Accountability in Action: How Three First 5's are Driving Program and System Change, led by ASR, as a way to highlight how RBA is being used from a county just starting RBA, to a county who has used it for several years, to a county who has been using it for quite a while.

The summit concluded with a keynote address by Clarissa Doutherd, Executive Director of Parent Voices Oakland, known for her work to bring together community based organizations, parents, and service providers to advance innovative strategies for County-wide systems of change and elevate parent leadership in public policy.



Community Engagement

Developmental Disabilities and Neurodiversity Conference 2024: The 2024 Developmental Disabilities and Neurodiversity Conference, sponsored by First 5 Solano, was attended by Deputy Director Denise Winters and Health Education Specialist Alicia Gutierrez from First 5 Solano. Scheduled for April 5th and 6th at the Joseph Nelson Community Center in Suisun City, this conference presented a valuable opportunity for First 5 Solano to stay informed about the latest advancements and best practices in the field. It serves as a platform to connect with experts, gain insights, and forge partnerships. Additionally, First 5 Solano will be participating in the resource fair to provide information, resources, and engage with community.

2024 Family Fun Fest: Health Education Specialist, Alicia Gutierrez is expected to table at the 2024 Family Fun Fest on April 10th at the Military & Family Readiness Center at Travis Airforce Base (AFB) in Fairfield. This event marks the 16th Annual Family Fun Fest which will highlight April as Autism Awareness Month, Child Abuse Prevention Month and the Month of the Military Child, among other recognitions. During the event, First 5 Solano will have an opportunity to connect with the military community and other agencies to provide resources, support and community engagement materials.

Vacaville Unified School District Extravaganza Event: The Vacaville Unified School District (VUSD) is holding a public event on April 13th at the Shelly Dally Early Learning Village to showcase the many Early Education options that are available for families in Vacaville. In addition to providing information about preschool, transitional kindergarten and kindergarten programs, the event will also offer on-site enrollment assistance, family activities and community resources. Health Education Specialist, Alicia Gutierrez is expected to host a community partner table to engage with families and provide First 5 Solano materials and resources.

Community Responsive Mini Grants: On April 8th, 2024, the first application period for all four types of mini grants (Community Engagement Event, Professional Development Opportunity, Equipment and Materials, and Time-Limited Program) will be open, with a total of \$30,000 available for events or activities taking place between July 1, 2024 and June 30, 2025. Applications are due April 29, 2024. The second application period will be released in October for event(s) or activities in January 1, 2025 - June 2025. The application will be made available through an electronic google form to provide easy access for community partners on the First 5 Solano website.

2024 Solano County Fair: First 5 Solano staff and grantees are meeting to plan the First 5 Family Zone at the Solano County Fair which will take place June 15th and 16th from 12 pm-6 pm. The fair has given First 5 Solano the opportunity to utilize a full lawn space for activities that will engage children ages 0-5 and their families. The theme for this year's event will be "Community", which will feature butterflies, honeybees and flowers from the 2024 First 5 Solano Calendar. The Family Zone will feature activities centered around literacy, family enjoyment, health and wellness. Collaborating with community partners, a range of resources and interactive activities will be available for families throughout the two-day event.

2024 Vallejo Juneteenth Celebration: On Saturday, June 15, 2024, the staff of First 5 Solano, including Kwiana Algere and Toya Adams, will actively participate in the 34th Annual Juneteenth Festival and Parade in Vallejo from 11am to 5pm. First 5 Solano is proud to support this event as a community partner, offering resources and First 5 Solano swag for children and families. Juneteenth, observed on June 19th, commemorates the emancipation of enslaved people in the US. As part of Vallejo's Juneteenth celebration, the festival will prioritize Community Health and Wellness, featuring a diverse array of food, activities, and resources for the community.
