Public invited to comment on environmental assessment for proposed Scotts Valley Casino and Tribal Housing Project development in Vallejo



A Solano County press release:

The U.S. Bureau of Indian Affairs (BIA) is now accepting public comments on the environmental impact assessment for the Scotts Valley Band of Pomo Indians

proposal for a Casino and Tribal Housing Project located in Vallejo.

The BIA issued an Environmental Assessment of the Scotts Valley Casino and Tribal Housing Fee-to-Trust Project on July 8 – initiating a 30-day public review period – analyzing the potential impacts that could result from the development of a gaming facility, including an eight-story casino with restaurants, bars, and a ballroom for events. In addition to a casino, the proposed project would also include the construction of 24 single-family residences, a tribal administration building, parking garage and a 45-acre biological preserve area on a 160-acre property located within and

adjacent to the City of Vallejo boundary in Solano County, near the intersection of Interstate 80 and Highway 37. The casino facility would be open 24 hours a day, 7 days a week.

The public is invited to analyze the potential environmental consequences of the Scotts Valley Band of Pomo Indians Casino and Tribal Housing Project, including any potential issues, concerns and alternatives that have not yet been raised during the BIA's review of the proposal, which includes transferring a 160-acre property into federal trust status for the benefit of the Tribe for gaming purposes.

After receiving feedback from the public on its environmental assessment, the BIA will decide whether to prepare an Environmental Impact Statement to further analyze the effects of the proposed development or proceed on the basis of lesser environmental analysis. The federal actions necessary to implement the Proposed Project trigger the requirements of the National Environmental Policy Act (NEPA). For this Environmental Assessment, the BIA will serve as the Lead Agency for compliance with NEPA.

Minority Health Month



July is BIPOC/Minority Mental Health Month, a time dedicated to raising awareness about the unique mental health challenges faced by historically underserved and underrepresented populations

including Black, Indigenous, Hispanic/Latino/a/x and People of Color.

This month, Solano County Behavioral Health will focus on promoting equitable mental health care and addressing the disparities that exist in services for these communities who often encounter barriers to mental health care, including stigma, cultural misunderstandings, and lack of access to culturally and linguistically responsive services.

In Solano, approximately 61% of the county population is identified as a race other than White/Caucasian. Persons who are Caucasian/White represent 39% of the population; 26% Hispanic/Latino; 14% African American/Black, 14% Asian American/Pacific Islander (AAPI); and 6% other race/ethnicity groups. At least 43% of the population speaks a language other than English often benefitting from linguistically appropriate or preferred services.



Draft 2025 Transportation Improvement Program

The [Draft 2025 Transportation Improvement Program \(TIP\)](#) is a funding document that helps implement the public's policy and investment priorities reflected in [Plan Bay Area 2050](#), the region's long-range plan. Updated every two years, the TIP reflects the Bay Area's near-term transportation investment priorities and helps some of the most significant projects and programs become a reality. It includes projects that support all modes of travel, such as transit, highways, bridges, local streets and roads, biking, walking and freight movement.

The Draft Transportation-Air Quality Conformity Analysis for the 2025 TIP is also available for public comment. The Conformity Analysis demonstrates that both the TIP and the plan comply with federal transportation air quality regulations.

The public comment period for both documents will remain open through 5 p.m. on Friday, July 26, 2024.



STA Board Approves Solano Rail Crossing Plan & Vallejo Passenger Rail Study



On June 12, 2024, the Solano Transportation Authority (STA) Board approved the *Vallejo Passenger Rail Study*. The study found that there is a significant travel demand from Vallejo to the North Bay counties, specifically to Napa and Solano through the Solano Rail Hub.

The Study recommends working with regional and state partners to advocate for the inclusion of rail service in Vallejo in the next California State Rail Plan. The STA and the City of Vallejo have identified future engagement with Caltrans, the Capitol Corridor Joint Powers Authority, and the appropriate adjacent counties to begin working on advancing concepts of rail service in Vallejo.

Math for the Trades Apprenticeship Preparation Class

Do you know anyone interested in a career that offers a living wage, on-the-job paid training, paid health benefits, and a secure pension plan? Then applying to one of the many Construction Apprenticeship Programs in the area might be a good fit.

The minimum qualifications for most apprenticeship programs include being at least 18 years old, a high school diploma, reliable transportation, and passing a basic math test.

For some people, the inability to pass the math test is a stumbling block in gaining access to these apprenticeship programs. The Vallejo Adult School, in partnership with CTWI, The Construction Trades Workforce Initiative, offers a unique math class designed specifically to help those interested in passing an Apprenticeship Entrance exam.

In a low stress environment, the class helps students master fractions, decimals, percentages, basic algebra, and basic geometry problems that they will encounter on the Apprenticeship Entrance exams.

This free class is offered Monday and Wednesday evenings from 6 to 9:15 p.m., at the Vallejo Adult School, 436 Del Sur St, Vallejo, 707-556-8850.

Community invited to groundbreaking at Allan Witt Park July 22



The community is invited to attend the Allan Witt Community Park All Inclusive Playground Project Groundbreaking Ceremony on **Monday, July 22 at 9 a.m. at 1741 W. Texas Street.**

The ceremony marks a significant milestone in the park's renovation and advances the city of Fairfield's efforts to create significant change to and activate the park in a positive way.

The project is approximately three acres and is east of the aquatics center and south of the dog park. Proposed improvements include the installation of drainage, water, sewer, and electrical utilities, concrete pathways, asphalt roads and parking lots, picnic areas, shade shelters, a gateway entry arch, play equipment, decomposed

granite paving, ramps, a prefabricated restroom building, retaining walls, fencing, landscaping, and irrigation.

Construction will kick off in late July and will continue through summer 2025. Working days will be Monday through Friday from 7 a.m. to 5 p.m. Once construction has commenced, the construction area will be delineated with construction fencing prohibiting public access for the duration of the project. Construction hours and days will be restricted during special events at the park

As part of the festival, we are planning a community photography project and are seeking Solano County contributors.

Have you seen changes to the natural beauty of Solano County? Has your family lived in Vallejo or other parts of Solano County for generations? We are looking for members of the community to contribute "then and now" photos. These photos should illustrate how an element of nature has changed, for better or worse, over several decades. Regional and local ballot measures



Two more regional and local measures have been placed on the November ballot:

They include Suisun City's [Measure S](#) which asks voters to renew a 1% sales tax at a 1.75% rate and extend the tax

for 15 years. Arguments for/against must be submitted to the Suisun City Clerk by August 16

The [Regional Measure 4 Resolution - Bay Area Housing Finance Authority \(BAHFA\)](#).

In November 2024, Bay Area residents could potentially vote on a regional bond measure to generate \$10 to \$20 billion to build more affordable homes and help keep existing homes affordable.

Ribbon cutting



The Greater Vallejo Recreation District (GVRD) will hold a ribbon cutting ceremony at Terrace Park at 4 p.m., Wednesday, July 17.

GVRD has invested over \$250,000 in improvements to Terrace Park on Daniels Ave. The State of California Prop. 68 Water Bond Act of 2018 will provide \$177,952 of the funding.

"We believe that upgrading the amenities in our parks will help more people stay active, spend time outdoors, and build stronger relationships with their neighbors," the district said in a press release.

On June 5, 2018, California voters passed Proposition 68 - the \$4 billion "Parks, Environment, and Water Bond Act of 2018" Funds were available for local park rehabilitation, creation, and improvement grants to local governments on a per capita basis.

Grant recipients were encouraged to utilize awards to rehabilitate existing infrastructure and to address deficiencies in neighborhoods lacking access to the outdoors. Staff chose to use the funding to replace both playgrounds at Terrace Park, which is a GVRD owned property.

The 2–5-year-old and 5–12-year-old play structures were replaced and a pour and play surface was added.
