Travis Unified School District believes that a high-quality education in a safe and engaging learning environment is the fundamental right of every student.

However, many of our schools were built 30-70 years ago and require critical repairs and upgrades to ensure the health and safety of all students. To succeed in the world today, our students must be skilled in the use of 21st-century educational technology and have a solid background in science, math and technology.

Measure R makes this possible by ensuring that all students have equal access to modern classrooms and learning tools. Measure R will also make essential improvements to school safety and security, including updating security systems, cameras, lighting, playgrounds, walkways and paving.

By law, all money raised by Measure R stays locally controlled to support local students. It cannot be taken away by the State or used for other purposes. If Measure R passes, the district has approved a resolution committed to dissolving the local Mello Roos Districts.
