The opponents don't understand Measure M and ignore these FACTS:

- **Yes on M brings Fairfield in line with other cities.** Fairfield's hotel/ motel tax was last updated 40 years ago and is lower than other cities in the area. Measure M simply brings our rate to the same as others.
- **Yes on M DOES NOT increase taxes on residents.** Measure M only impacts guests staying in hotels and motels in Fairfield and does not increase taxes on residents by one dime.
- **Yes on M ensures visitors to Fairfield pay their fair share.** When visitors stay in Fairfield, they use our infrastructure and services. Measure M ensures visitors pay their fair share for the local city streets, police, fire protection, and rapid emergency response they rely upon.
- **Yes on M means local control for Fairfield.** Measure M gives Fairfield local control over local funds for local needs. Every penny stays in Fairfield and cannot be taken away.
- **Yes on M protects essential services in Fairfield.** Locally controlled funding will help repair potholes, maintain local streets, support fire protection, neighborhood police patrols, and rapid 9-1-1 emergency response.
- **Yes on M requires fiscal accountability.** Annual independent audits and public disclosure of all spending ensures that all funds are spent properly.

Vote Yes on M, and its companion Measure L, to maintain essential services in Fairfield without increasing taxes on residents.
