3. AB 939 COUNTYWIDE INTEGRATED WASTE MANAGEMENT PLAN UPDATE

Countywide Siting Element (CSE) Planning Period 2025-2040 Staff: JT Lee, Assistant Planner, Solano County JTLee@SolanoCounty.com

The California Integrated Waste Management Act of 1989 (AB 939), as amended (Section 40000 et seq. of the California Public Resources Code), requires each county to prepare a CSE that describes how the county, and the cities within the county, plan to manage the disposal of their solid waste for a 15-year planning period. The CSE must be approved by a majority of the cities, containing a majority of the incorporated population in the county, by their respective City Council and Board of Supervisors before consideration of final approval by the California Department of Resources Recycling and Recovery (CalRecycle).

- 1995-2009 Solano County CSE (November 1995): California Integrated Waste Management Board (CIWMB) – Approved 1996
- 2010-2025 Solano County CSE (July 2011): CalRecycle – Approved 2012

4. SB 1383 SHORT-LIVED CLIMATE POLLUTANTS REDUCTION STRATEGY

California jurisdictions are required to implement an edible food recovery program to reduce food waste and help address food insecurity. A minimum of 20% of edible food, that would otherwise be landfilled, must be recovered to feed people in need. Solano County's Department of Resource Management has developed a compliant edible food recovery program that can be implemented on behalf of each city within the county upon mutual agreement.
