



#### **Status of NE Taxilane Grant Projects**

#### **DESIGN:**

**Great news!** The Airport just received word we've been awarded a matching grant from Caltrans in the amount of \$15,142. This is in addition to the FAA Grant of \$221,493 for the design work on the NE Taxilane Reconstruction Project. You may have noticed the surveyor on site last week surveying the Taxilane area, which is the start of work on the new design.

#### **RECONSTRUCTION:**

A pre-application has been submitted to the FAA, requesting \$3.04 million grant to fund the Reconstruction portion of the Taxilane. Due to the high cost of construction, this project was split into two phases per FAA direction, one phase covering the "rib" portion of the Taxilane on the north side and the other on the south. Currently the project for the north side is funded at \$1.9 million. We are working with the FAA local office to get the additional funding, as well as exploring strategies of how to move forward if no additional funding becomes available.

Mead & Hunt, the consulting firm heading up the project, will

be at the Airport along with Royal Electric to assess the lighting on the runway. The assessment team will need some temporary runway closures on Monday, Nov 13<sup>th</sup> and Tuesday the 14<sup>th</sup>. Airport staff is working with them to minimize interruption of aircraft operations. Once the schedule is determined, airport staff will issue a NOTAM and send an email to update tenants.

This assessment is the first step in multi-year FAA grant funding and will allow us to move forward in scoping, design, and construction of improvements to critical lighting systems at our airport – including runway, taxiways, navaid, and rotating beacon. We appreciate your patience as work is done to complete this stage of the project.

#### **Office Closures**

### **Elevator Upgrade Update**

The upgrade work to the elevator in the Administration Building is almost complete. The project is ahead of schedule and is expected to be done by November 1st. Signs will remain in the Administration Building, however, until the State completes their inspection and certifies the elevator compliant with State requirements.

## Safety/Courtesy Message of the Month – Parking your car without Blocking others

The Airport has received several complaints recently of cars parked in locations that make navigating into and out of a hangar difficult for other tenants, as well as vehicles parked in fire lanes. Please make sure that you (or guests you invite onto the airfield), park in accordance with the Nut Tree Airport's Rules and Regulations, approved by the Board of Supervisors, and that you are being a good neighbor to your fellow tenants and not blocking or limiting their access to the airfield or their hangar.

Here's an excerpt from Chapter 2.4-28 of the Solano County Code for all airports in the County, regarding parking of Motor Vehicles:

"All persons using the airport shall operate automobiles, motorcycles, trucks, or tugs in accordance with the following rules:

- A. Vehicles shall be parked within the parking areas approved by the Airport Manager only.
- B. No common carrier vehicle or vehicle for hire shall load or unload passengers or stand at the airport in any place other than in the area designated by the Airport Manager.
- C. Vehicles shall not be operated beyond roads and parking area limits or on the ramps or aprons except by persons assigned to duty there or authorized by the Airport Manager.
- D. No person shall operate any vehicle in any of the landing or taxiway areas, unless authorized to do so by the Airport Manager and then only in the manner prescribed.
- E. Vehicle speed shall be limited to fifteen (15) miles per hour within the airport parking areas.
- F. The Airport Manager shall have authority to move vehicles parked in improper locations, and the owners of such vehicles shall be responsible for payment of any towing charges necessitated thereby."
