

Drivers who cross the Bay Area's seven state-owned bridges—including the Carquinez and Benicia-Martinez bridges in Solano County—could see a series of annual toll hikes for bridge maintenance lasting into 2030.

These proposed increases <u>are</u> <u>separate</u> from the recent toll hikes for transportation projects that voters approved in 2018 (Regional Measure 3). One-way tolls are currently \$7 and are slated to rise to \$8 in January.

The Bay Area Toll Authority is considering increasing tolls on the region's seven state-owned bridges by 50 cents a year from 2026 through 2030. Tolls were already set to increase to \$8 for all bridges on Jan. 1, 2025. Under the proposal, on Jan. 1, 2026, tolls would rise to \$8.50. On Jan. 1, 2027, tolls would rise to \$9 for those with FasTrak transponders, \$8.25 for those with license plate accounts, and \$10 for other drivers. On Jan. 1, 2028, tolls would rise to \$9.50 for those with FasTrak transponders, \$9.75 for those with license plate accounts, and \$10.50 for other drivers. On Jan. 1, 2029, tolls would rise to \$10 for those with FasTrak transponders, \$10.25 for those with license plate accounts, and \$11 for other drivers. On Jan. 1, 2030, tolls would rise to \$10.50 for those with FasTrak transponders, \$10.75 for those with license plate accounts, and \$11.50 for other drivers.

The Bay Area Toll Authority has borrowed \$56 million since 2021 to pay for bridge preservation. Borrowing another \$600 million over the next five years would result in having to pay back \$690 million, including interest, according to the report.

Drivers paid a toll of 40 cents on the Carquinez and Benicia-Martinez bridges in the late 1980s, or \$1.04 in today's money. That was before a series of voter-approved increases for transportation projects and authority-approved increases for seismic retrofitting.

People can weigh in on the proposed toll increases during a comment period that begins Monday, Nov. 4 and continues through 5 p.m. Tuesday, Dec. 3. They can send comments to <a href="mailto:info@bayareametro.gov">info@bayareametro.gov</a>

The toll authority and MTC will host a public webinar from 6:30 to 8 p.m. Wednesday, Nov. 13 to present details about the proposed toll hike.

The two agencies will hold a public hearing at 9:30 a.m. Wednesday, Nov. 20 in San Francisco. Members of the public will be able to participate in person or via Zoom.

This was adopted by the Bay Area Toll Authority, so the public does not get to vote on the increases. This is the time to make your voice heard!

#### **Ride Free to Vote 2024**



We're free to vote, SolTrans is Free to Ride. Ride free all day on Tuesday, November 5 on all local and paratransit service

SolTrans, which operates in the cities of Vallejo and Benicia, will offer free rides on all local and paratransit services on **Election Day, Tuesday, November 5,** to help community members access the polls.

Exercising the right to vote is so important, that SolTrans wants to make it as easy as possible to get to the polls. Free rides will be on all local routes for all riders, and paratransit trips will be free for all ADA-eligible persons. Reservations are required for Paratransit service, please follow normal protocol to book a paratransit trip on or before November 1.

To find your Solano County polling place and check your voter status, visit <u>Solano County Registrar Voters</u>. Riders can plan their travel early.

For help planning your trip, customers can plan a trip with SolTrans' <u>trip planner</u>. Be ready to provide the starting address and the address of the polling place you will be traveling to.

# Solano County still looking for poll workers



John Gardner, Solano County Assistant Registrar of Voters, has confirmed that the county is still accepting applications for poll workers on Election Day, Tuesday, Nov. 5.

There are positions open at the Solano County Registrar of Voters on Election Day/night too.

John also said that ballots should be 98%+ delivered on Friday, Oct. 11 – but if someone hasn't received their ballot, they should reach out to the Solano County Registrar of Voters on Tuesday, Oct. 15 as the county administration will be closed on Monday, Oct. 14 in observance of Indigenous Peoples' Day. (closed on Monday). #### **Medicare Open Enrollment**



Congressman John Garamendi is reminding persons that Medicare Open Enrollment is now underway and runs through December 7.

From Congressman Garamendi:

"In 2022, I proudly voted to pass the Inflation Reduction Act, empowering Medicare the power to negotiate lower prescription drug

prices and reduce healthcare costs for seniors.

As your voice in Congress, I am committed to fighting for universal healthcare and protecting Americans' existing healthcare rights. I'm excited to share the progress we've made to improve our community's access to healthcare.

Thanks to the Inflation Reduction Act (IRA), Medicare now has the authority to negotiate lower prescription drug prices. Beginning in January, total out-of-pocket costs for prescription drugs will be capped at \$2,000 annually, ensuring seniors never pay more than that for medications covered under Medicare, including those used to treat cancer and chronic illnesses.

The IRA also caps the cost of insulin for seniors with diabetes at \$35 a month. In California's 8th District, approximately 74,000 individuals living with diabetes, and 20,000 rely on daily insulin. Medicare beneficiaries who depend on insulin are now saving an average of \$320 annually compared to 2020 prices.

In 2010, I voted to pass the Affordable Care Act, which has helped tens of millions of Americans access affordable, high-quality health insurance. As of 2024, about <u>26,000</u> of my constituents are enrolled in the Affordable Care Act marketplace, a <u>16%</u> increase since 2020. Thanks to the IRA, the average enrollee will save <u>\$2,630</u> in premiums this year. Without the IRA's enhanced subsidies, the average premium would have increased <u>117%</u>, to an average of \$4,870.

I encourage every senior in our community to take advantage of these new, lower-cost Medicare benefits. It is more important than ever to look at your drug coverage for 2025 during Medicare Open Enrollment and make sure you are enrolled in the Medicare Part D plan that is best for you. The United States Coast Guard (USGC) requires boaters to carry several unexpired visual distress signals on board, day and night. Pyrotechnic marine flares are a common type of distress signal, but they are explosive hazardous waste and contain toxic chemicals, like perchlorate, that pose human health risks. Marine flares only work once and expire 36 to 42 months after the manufacture date.

For safety and environmental reasons, it is essential to manage single-use pyrotechnic marine flares carefully. Residents should never throw flares overboard into the environment or out in household trash. However, California resident boaters do not have access to an ongoing expired marine flare disposal program, and recreational vessels generate about 174,000 pyrotechnic marine flares every year, according to the California Expired Marine Flare Working Group as estimated in 2012.

# California Invests Nearly \$4 Billion to Improve Train Corridors, Bridges, Roadways, and Walking and Bicycle **Pathways**



The California Transportation Commission (CTC) today allocated approximately \$3.8 billion for projects that will continue to refurbish the state's transportation infrastructure, enhance safety and create more options for the traveling public.

The projects will improve coastal rail lines, freight corridors, bridges, highway interchanges and system enhancements aimed to increase accessibility for multi-modal users.

Nearly \$3.5 billion of today's investment is funded through the landmark federal Infrastructure Investment and Jobs Act of 2021 (IIJA). More than 75 percent of that allocation will be sent to approximately 600 local governments and regional transportation authorities to replace bridges, reduce travel times for commuters, address planet-warming pollution, improve highway and rail safety and efficiency and provide new transportation services. Another approximately \$330 million in funding comes from Senate Bill (SB) 1, the Road Repair and Accountability Act of 2017.



# **Green Valley Subdivision public hearing**



The Solano County Board of Supervisors will hold a public hearing on Tuesday, November 5, to consider a time extension request through October 4, 2034 to file the Small Lot Final Map for Major Subdivision Application No. S-21-01 (Wagner), which proposes to divide 27 existing parcels into 322 separate residential parcels and multiple additional parcels for right-of-way, parks and open space,

Village Green, Community Service uses, and stormwater detention areas, near the intersection of Green Valley Road and Mason Road north of the City of Fairfield within the Middle Green Valley Specific Plan area in unincorporated Solano County.

The hearing is limited to the time extension request, and because the original project approval was found to be exempt from additional environmental review under CEQA Guidelines 15168 (c) and no other changes to the project are proposed, no additional CEQA compliance is required.

Any person wishing to review this information may do so at the Solano County Department of Resource Management, Planning Division, County Administration Center, 675 Texas Street, Suite 5500, Fairfield.

The hearing will be held in the Board of Supervisors Chambers, County Administration Center, 1st Floor, 675 Texas Street, Fairfield on Tuesday, November 5, at 9 a.m. or as soon thereafter as the matter may be heard.

# Fairfield Forward 2050: Next steps through adoption

The public comment period for Fairfield Forward 2050, consisting of a General Plan Update, Climate Action Plan, and Environmental Impact Report (EIR), closed in September 2024. The Public Drafts remain available on the Fairfield Forward 2050 project website at www.fairfieldforward.com.

Public comments will be published on the project website after Wednesday, October 9. Responses to Draft General



Plan Update and Draft Climate Action Plan comments will be provided in future staff reports for the Planning Commission and City Council. Responses to Draft EIR comments will be provided in the Final EIR.

Next steps through adoption are as follows:

- November 6, 2024: Special meeting of the Planning Commission to review and make a recommendation to the City Council
- December 3, 2024: Regular City Council meeting to vote on the adoption of the Fairfield Forward 2050 project

# Notice of Public Availability of 2024 Refinery Flare Minimization Plan Annual Updates



The Bay Area Air Quality Management District (BAAQMD) is releasing the 2024 Flare Minimization Plan (FMP) Annual Updates for public review and comment. The five Bay Area refineries prepared these plans subject to Regulation 12, Rule 12: Flares at Refineries.

Under Regulation 12-12, each FMP Annual Update must include:

- New prevention measures identified during investigations of flaring events that occurred during the period July 1, 2023 – June 30, 2024;
- A description of the prevention measures previously taken or currently planned to reduce flare emissions at the refinery;
- Commitment to implement all new feasible prevention measures expeditiously; and
- A 30-day public comment review period

The plan updates are now available for review on the Air District's <u>Flare Minimization Plans</u> web page.

The deadline to submit public comments regarding the 2024 FMP Annual Updates is **November 8.**

Be sure to identify which refinery, or refineries, your comment is applicable to.

After consideration of public comments received, the Air District will evaluate each refinery's Flare Minimization Plan Annual Update to determine whether it meets the requirements of Regulation 12-12 and will take final action in accordance with the regulation.

The hall is located at 1150 1st Street in downtown Benicia.






#### Floating Pumpkin Patch at Allan Wit




