The Solano County Registrar of Voters (ROV) issued a public notice for random draw of the minimum 1% Manual Tally per EC 15360 with the random selection to commence Wednesday November 20, 2024, at 10:00 a.m. One observer from the public attended. The audit was conducted from Wednesday, November 20, 2024, through Wednesday, November 27, 2024.

The ROV audited Poll Place and Vote by Mail (VBM) ballots as separate categories as shown below:

Poll Place Manual Tally:

Three (3) Poll Places were randomly drawn for manual tally. A total of 17 out of 238 precincts comprised of 3 of 68 polling places were selected. This represents 1,053 (3.70%) of the total Election Day ballots cast for the election.

The manual tally confirmed the machine counts for all poll place ballots as follows:

Vote by Mail Manual Tally:

For VBM ballots, Solano County utilized batches of up to 200 ballots. 63 batches were randomly drawn for manual tally, representing 9,803 (6.28%) of the total VBM ballots cast for the election.

Summary of Audit:

Overall, 3 of 68 poll places (4.41%) and 63 of 1,030 VBM batches (6.12%) were completely manually audited, representing 1,053 of 28,432 poll ballots (3.70%) and 9,803 of 156,116 VBM ballots cast (6.28%) respectively.

In each case, the hand count of ballots matched the machine count for the election.
