DRAFT MINUTES

1. Roll Call/Call to Order

Vice Chair Steve Young called the meeting to order at 5:01 P.M. Present were the Mayor of Benicia Steve Young, Mayor of Vallejo Robert McConnell, Mayor of Suisun City Alma Hernandez, Mayor of Vacaville John Carli, Mayor of Dixon Steve Bird, and Mayor of Rio Vista Ron Kott. Absent: Mayor of Fairfield Catherine Moy

2. Public Comment

There was no public comment.

3. Business:

A. Approve the Minutes of the March 20, 2024, City Selection Committee regular meeting.

On motion of Mayor Bird, and seconded by Mayor Hernandez, the Committee acted to approve the minutes of the March 20, 2024 regular meeting. So ordered by a 6-0 vote with Mayor Moy Absent

B. Nomination to the Solano County Board of Supervisors for appointment of one (1) representative to the Metropolitan Transportation Commission (MTC) for a 4-year term to expire February 9, 2027 (3 nominations required to be submitted to the Board of Supervisors)

Vice Chair Young made a motion to postpone the nominations for the MTC position for two weeks to allow time for the newly elected mayors to have input into the appointment. Mayor McConnell seconded the motion. The motion failed on a 3/3 vote with Mayor Moy absent.

Mayor Kott stated it is his belief that the current roster of Mayors on this committee have a good perspective of the requirements for being an MTC Commissioner and are better qualified to make the recommendation. Mayor Kott offered a substitute motion to vote on the item as agendized. Mayor Bird seconded the motion. The motion failed by a 3/3 vote with Mayor Moy absent. Motion was technically not needed as failure of the original motion required the item to move forward.

Vice Chair Young opened the floor for public comment.

Supervisor Elect Cassandra James commented in support of postponing the nominations to provide the newly elected mayors with the opportunity to participate in the nomination process. Supervisor Elect James further stated it is equitable to allow the newly elected individuals who will be representing Solano County moving forward the opportunity to have an impact on projects that will affect Solano County.

Mayor Hernandez asked about the timeline for MTC Commissioner James Spering's retirement, noting she is aware that Commissioner Spering had requested time to transition and provide a warm handoff to the newly appointed MTC Commissioner.

Vice Chair Young stated MTC Commissioner Spering has submitted his resignation effective January 31, 2025, but has indicated he is willing to postpone his resignation for 1 additional month should the City Selection Committee decide to postpone the nominations.

In response to a question from Mayor Kott regarding the date of the first January 2025 Board of Supervisors meeting, Secretary Alicia Draves stated the first meeting of 2025 will be January 7, 2025.

In response to a question from Mayor Hernandez regarding when the item would be brought back before the Committee, Vice Chair Young stated it would be brought back on December 18, 2024.

Mayor McConnell provided his reasoning for desiring a postponement, noting the Vallejo City Council has a new majority as a result of the November election and he believes each will have an opinion on how to handle transportation projects in Solano County.

Mayor Bird commented in support of not postponing the nomination, stating he believes the current City Selection Committee has the experience to make the nomination.

A discussion period was held regarding nominations for the MTC position with the following names being put forward for consideration:

Mayor Kott nominated Solano County Supervisor Mitch Mashburn. Mayor Bird seconded the nomination.

Mayor Hernandez nominated former City of Vallejo City Council Member Pippen Dew. Mayor Bird seconded the nomination.

Mayor McConnell nominated Solano County Supervisor Wanda Williams. Vice Chair Young seconded the motion.

Vice Chair Young nominated Benicia City Council Member Trevor Macenski. Mayor McConnell seconded the motion.

Discussion was held regarding the nominated individuals.

In response to a question from Mayor McConnell on the potential conflict of interest for Ms. Dew who serves on the San Francisco Bay Ferry Board, County Counsel Bernadette Curry stated that she wasn't sure if it would be a conflict, but if it was a conflict of interest, Ms. Dew would have to resign her position on the San Francisco Bay Ferry Board were she to be appointed to the MTC.

Vice Chair Young called for the vote on the 4 nominations.

The nomination of Supervisor Mitch Mashburn was carried on a vote of 3/2 with one abstention from Mayor Hernandez.

The nomination of Former Council Member Pippen Dew was carried on a vote of 6/0.

The nomination of Supervisor Wanda Williams failed on a vote of 2/4.

The nomination of Council Member Trevor Macenski was carried on a vote of 6/0.

On motion of Mayor Kott, and seconded by Mayor Bird, the Committee acted to approve the nomination Solano County Supervisor Mitch Mashburn for the appointment to the MTC. So ordered by a 3-2 vote with Mayor Hernandez abstaining and Mayor Moy absent.

On motion of Mayor Hernandez, and seconded by Mayor Bird, the Committee acted to approve the nomination Pippen Dew for the appointment to the MTC. So ordered by a 6-0 vote with Mayor Moy absent.

On motion of Vice Chair Young, and seconded by Mayor McConnell the Committee acted to approve the nomination Benicia City Council Member Trevor Macenski for the appointment to the MTC. So ordered by a 6-0 vote with Mayor Moy absent.

B. Appoint one (1) Primary representative to the Remote Access Network (RAN) Board for a term through December 31, 2024

Chair Bird called for nominations.

On motion of Mayor Bird, and seconded by Mayor Hernandez, the Committee acted to appoint Mayor Carli as Primary representative to the Remote Access Network (RAN) Board for a term through December 31, 2025. So ordered by a 6-0 vote with Mayor Moy absent.

C. Selection of Chair and Vice-Chair for 2025

On motion of Mayor McConnell, and seconded by Mayor Hernandez, the Committee acted to appoint Mayor Young as the Chair of the Solano County City Selection Committee for the 2025 calendar year. So ordered by a 6-0 vote with Mayor Moy absent.

On motion of Mayor Kott, and seconded by Mayor Young, the Committee acted to appoint Mayor Hernandez as the Vice-Chair of the Solano County City Selection Committee for the 2025 calendar year. So ordered by a 6-0 vote with Mayor Moy absent.

D. Approve Meeting Schedule for 2025

Discussion was held regarding the 2025 meeting schedule.

On motion of Mayor Carli, and seconded by Mayor Young, the committee approved the Meeting Schedule for 2025 as follows: January 15, 2025, April 16, 2025, July 16, 2025, and October 15, 2025. So ordered by a 6-0 vote with Mayor Moy absent.

- F. Cancellation of the December 18, 2024, City Selection Committee regular meeting On motion of Mayor Carli, and seconded by Vice Chair Young, the committee approved the cancellation of the December 20, 2024, Regular Meeting. So ordered by a 6-0 vote with Mayor Moy absent.
- H. Discussion and review of other appointments as needed.

No discussion was held.
