PROJECT SUMMARY:

The Community Development Department has received an appeal of the Community Development Department Director's approval of the Brown Street (De Colores) Park to be located on the east side of Brown Street, adjoining the Solano County Health and Social Services office building. The project was approved by the Director on October 31, 2024, which allowed the construction of a park to be built in two phases on a vacant 3.48-acre lot. Phase 1 would include the park play area, parking, a recreation center, and a masonry wall along the northern portion of the site. Phase 2, based on the availability of funding, would include the City's Housing and Community Services office building, additional parking, and a masonry wall along the eastern property line of the site, abutting an existing Manufactured Housing Park. The appeal was filed by Steven Strem ("Appellant") on November 12, 2024. The Appellant is seeking to include the construction of the masonry wall along the eastern property line with Phase 1. The Appellant has indicated the existing chain-link fence is inadequate for blocking noise from the future park.

Pursuant to Sections 15063 and 15073 of the California Environmental Quality Act (CEQA), the City of Vacaville prepared and circulated an Initial Study / Mitigated Negative Declaration (SCH No. 2024090073) to disclose projectrelated impacts on the environment. All impacts are anticipated to be less than significant with the incorporation of mitigation measures.
