A message from Congressman John Garamendi's Office:

It was a busy week! We learned this week that Donald Trump and the Department of Homeland Security have begun plans to create a mass immigration detention facility at an air force base in our district. Let me be clear: **Travis Air Force Base is absolutely inappropriate for an immigration detention facility.** It plays

a critical national security role, providing global transportation for personnel and material, especially in support of Ukraine.

We must push back against Trump's mass deportation plans before they compromise our national security.

Introduced the SHIPS Act to Revitalize Mare Island

America's dangerous maritime decline threatens our national security as international competition for trade, commerce and military power in the Pacific grows. To maintain our economic and military strength, America must rebuild its maritime industry. That's why I, alongside Sens. Mark Kelly (D-AZ) and Todd Young (R-IN), and Rep. Trent Kelly (R-MS), introduced the bipartisan, bicameral SHIPS for America Act.

The bill sets an ambitious national goal of expanding the U.S.-flagged international fleet by 250 ships over 10 years, promises to bring new high-skilled and high-paying jobs to Mare Island, and

invest in overdue infrastructure upgrades for the California Maritime Academy and a new Golden Bear multisession training ship.

As Rosie the Riveter said, "We can do it." So, let's get it done."

Seven Amendments Introduced

This week, my committees – the House Armed Services and Transportation and Infrastructure Committees – met to debate next year's budget. House Republicans are trying to pump money into Trump and Hegseth's military while slashing infrastructure funding for roads, bridges and highways - even in their own districts. These Republican budget proposals cut funding for essential services our communities need, **all to give tax cuts to billionaires**.

I was proud to introduce seven amendments to push back hard against the House Republicans' budget plans. Attorney General Bonta Announces Fifth Edition of Disability Rights Handbook



From the office of California Attorney General Rob Bonta:

California Attorney General Rob Bonta, through the California Department of Justice's Disability Rights Bureau, announced the release of the fifth edition of "Legal Rights of Persons with Disabilities," a

publication that provides information regarding the rights of people with disabilities in California. This handbook summarizes state and federal laws that protect the rights of individuals with disabilities in many arenas, including in the workplace and in accessing facilities open to the public. The handbook covers disability rights and obligations in a variety of contexts including businesses and places of public accommodation, employment, housing, K-12 education, healthcare, voting, and telecommunications, with chapters released on an ongoing basis since January 2024.

"At California DOJ, we are committed to ensuring that all individuals have access to inclusive and respectful environments free from discrimination, including discrimination based on disability," **said**

Attorney General Bonta. “Nearly one quarter of adults in California have a disability, and with the latest edition of this handbook, we aim to provide valuable information on disability rights to support accessibility and full participation for all Californians in every aspect of daily life.”

Californians with disabilities face widespread discrimination, segregation, and exclusion in many aspects of everyday life. California’s disability rights laws are designed to provide protection from these harmful practices, but Californians are often unaware of the nature and scope of these complex laws. All chapters of the “Legal Rights of Persons with Disabilities” handbook are available at <https://oag.ca.gov/civil/disability-rights> including new and updated chapters on:

1. **[Introduction to State and Federal Disability Rights Laws](#)**: This chapter provides an overview of major California state and federal laws that protect the rights of people with disabilities.
1. **[Access to Businesses and Other Public Accommodations for People with Disabilities](#)**: This chapter discusses California and federal laws that prohibit disability-based discrimination in business establishments and other public accommodations. It also describes an individual’s options when they have experienced disability-based discrimination in business establishments and other public accommodations.
2. **[Access to Healthcare for People with Disabilities](#)**: This chapter describes the state and federal laws that protect the rights of people with disabilities to access healthcare services, including hospitals and other facilities, services, insurance plans, and information offered by doctors’ offices and other medical providers. It also describes an individual’s options when they have experienced disability-based discrimination in healthcare services.
3. **[Disability Rights in Employment](#)**: This chapter discusses major California and federal laws that protect people with disabilities from discrimination, harassment, and retaliation in employment. It also describes an individual’s options when they have experienced discrimination in employment because of their disability.
4. **[Disability Rights in Housing](#)**: This chapter discusses California and federal laws that protect persons with disabilities from public and private housing discrimination. It also describes options when persons with disabilities have experienced discrimination in housing because of their disability.
5. **[Disability Rights in K-12 Education](#)**: This chapter discusses the rights of students with disabilities in pre-school, primary, and secondary education under California state and federal law.
6. **[Access to Voting for People with Disabilities](#)**: This chapter discusses access to polling places and the voting process under federal and state election laws. Additionally,

this chapter describes an individual's options when they have experienced discrimination because of their disability while registering to vote or voting.

7. **[Access to Public and Private Buildings and Facilities for People with Disabilities](#)**: This chapter provides an overview of state and federal laws that set requirements for physical accessibility of both public and private buildings and facilities. In addition, this chapter provides information regarding options for individuals who have experienced discrimination regarding physical accessibility.
8. **[Access to Telecommunications for People with Disabilities](#)**: Telecommunications services are services that allow people to communicate through cable, radio, television, satellite, or wire equipment and include a variety of services like telephone and text message services. This chapter details state and federal laws regarding telecommunication services ensuring that people with disabilities have equal access to said service. It also provides information if there are concerns about accessibility of a product or service.
9. **[Benefits and Services for People with Disabilities](#)**: This chapter highlights state and federal benefits, programs, and services that are designed to assist people with disabilities.
10. **[Service Animals](#)**: This chapter discusses the rights of people with disabilities to use service animals and emotional support animals under both federal and California laws. This chapter also provides the various complaint options people have when their rights regarding service or emotional support animals have been violated.

Attorney General Bonta is committed to supporting the rights of Californians with disabilities and enforcing state laws that protect people from discrimination. He has [supported an update](#) to the Americans with Disabilities Act's (ADA) Title II regulations concerning accessibility of web information and services of state and local government entities, [defended access to housing](#) for persons with disabilities, and [recommended revisions](#) to strengthen and protect the rights of students with disabilities under Section 504 of the Rehabilitation Act of 1973. This handbook demonstrates the Attorney General's ongoing commitment to enforcing these laws and ensuring that all Californians are protected from discrimination.

Eastbound and Westbound- I-80 Fairfield



From a Caltrans press release:

Caltrans and its transportation partner, the Metropolitan Transportation Commission (MTC) will be testing signage for the new I-80 Solano Express Lanes. The signs are located on

eastbound and westbound I-80 between Red Top Road and Manuel Campos Parkway in Fairfield.

During testing, the signs will be illuminated with test messaging. The signage testing will occur starting Friday, May 9 until tentatively late summer 2025. Motorists will see test messaging on the signs each day beginning at 9:00 AM until 5:00 PM, Mondays-Fridays. Motorists will NOT be charged to use the new far-left traffic lanes on I-80 in Fairfield and Vacaville during this testing phase. They will continue to be allowed to use the far-left traffic lanes on eastbound and westbound I-80 in Fairfield and Vacaville as a temporary car-pool lane during commute hours and use those same lanes as a traffic lane with no restrictions during non-commute hours.

After the testing phase is completed, sometime in late 2025, the signs will be activated and motorists using the new express lanes, the far-left traffic lane, will be charged based on Express Lane charging criteria.

56-Hour Closures scheduled to begin in March for Rio Vista Bridge



From a Caltrans press release:

Caltrans is advising motorists of six scheduled weekend closures of the Rio Vista Bridge (Helen Madere Memorial Bridge) on State Route 12

(SR 12) for ongoing repairs.

This \$27.2 million project is funded through the Bridge Rehabilitation and Replacement Program and will require multiple 56-hour weekend closures for the work to be completed because of the limited width of the bridge to allow for heavy equipment access.

The project is making necessary mechanical repairs, replacing the movable deck span and replacing bridge rails.

During the weekend closures that are scheduled between March and June, the contractor will replace the movable span bridge deck concrete, and 60 steel stringers needed to extend the service life of the bridge.

Due to the limited width of the existing bridge deck, 56-hour weekend bridge closures are necessary to facilitate safe access to the work for contractor and Caltrans personnel.

The 56-hour weekend bridge closure schedule will lessen total project workdays and help avoid the wait times at peak commute hours during the week.

Motorists could encounter additional travel times of up to two hours using detours from Rio Vista to Sacramento County on SR 12 across the Sacramento River. Please allow for extra travel time to reach your destination, especially for scheduled appointments and work schedules.

Schedules are subject to change due to weather conditions, equipment or material availability, or other unexpected events.

Caltrans District 3 is responsible for maintaining and operating 4,385 lane miles in 11 Sacramento Valley and Northern Sierra counties. Caltrans reminds motorists to “Be Work Zone Alert” and slow in construction zones for the safety of travelers and crews performing these improvements.

Interstate 80 Scheduled for Multiple Closures in Yolo County

From a Caltrans press release:

Caltrans is alerting motorists of an upcoming extended connector and on-ramp closure for the ongoing Yolo Interstate 80 (I-80) and U.S. Highway 50 (US-50) Pavement Rehabilitation Project.

The mainline between I-80/US-50 connector ramp to Reed Avenue will be reduced to two lanes after the end of a 55-hour closure from May 12 through May 21.

Construction work will include a full closure of eastbound (EB) I-80 after crossing the EB I-80 Yolo Causeway from Davis going towards Reed Avenue in West Sacramento. Caltrans urges motorists to plan for additional travel time, to expect delays and use the designated detour route. (see maps)

Ongoing pavement replacement and striping work will continue for the EB direction of I-80 and US 50 in West Sacramento.

SCHEDULED CLOSURE #1:

- Eastbound (EB) I-80 connector ramp to EB Reed Avenue, westbound (WB) US50 connector ramp to EB I-80, Enterprise on-ramp to EB I-80 and EB I-80 to Reed Avenue off-ramp
 - **55-hour full closure** - From 9 p.m. Friday, May 9 through 4 a.m. Monday, May 12

- **Nightly full closures** - From 9 p.m. to 4 a.m.
Monday, 5/12 to Sunday, 5/18 and 11 p.m. – 4 a.m.
Monday, May 19 to Wednesday, May 21

DETOUR:

- EB I-80 traffic will be detoured to EB US-50 to Sacramento over the Sacramento River to northbound I-5 to Redding (EXIT 4A), to east I-80 to Reno (EXIT 522).
- From WB US-50, take the Enterprise Boulevard off-ramp (EXIT 81) and stay left, continue onto Enterprise to Industrial Avenue (left turn at light) continue Industrial to Harbor Boulevard (left at light) for EB US-50 to Sacramento (EXIT 82), continue over Sacramento River to northbound I-5 to Redding (EXIT 4A), to eastbound I-80 to Reno (EXIT 522).

SCHEDULED CLOSURE #2:

- Reed Avenue loop on-ramp to EB I-80 closed
- **72-hour full closure** from 5 a.m. Monday, May 12 through 5 a.m. Thursday, May 21

DETOUR FOR CLOSURE #2:

- From Reed Avenue, continue west on Reed, (left turn at signal) take westbound I-80 to the San Francisco on-ramp, to EB US-50 to Sacramento (EXIT 82), continue over the Sacramento River to northbound I-5 to Redding (EXIT 4A), to east I-80 to Reno (EXIT 522).

The work zone is from the Yolo Causeway through West Sacramento on I-80 and US 50. The speed limit has been reduced to 55 miles per hour 24/7 for the safety of workers and motorists. Work is scheduled to begin as listed but subject to change due to traffic incidents, weather conditions, availability of equipment and/or materials, and construction-related issues.

The extended lane closures will help to minimize the duration of the work and improve workers' safety.

This \$280 million project includes \$47 million from Senate Bill (SB 1), the Road Repair and Accountability Act of 2017. SB 1 provides \$5 billion in transportation funding annually, shared equally between state and local agencies. Road projects progress through construction phases more quickly based on the availability of SB 1 funds, including projects partially funded by SB 1.

Air District Soliciting Applications for Community Advisory Council Seats

The Air District is soliciting applications for thirteen seats on its Community Advisory Council (CAC). The thirteen open seats represent: Alameda County, Contra Costa County, San Francisco County, San Mateo County, Santa Clara County, and Solano County, as well as at-large and youth seats.



In November 2021, the Board of Directors approved the formation of the Air District's inaugural CAC, consisting of 17 community members from across the Bay Area. The Board created the CAC in response to community input and to support an equity-forward policy agenda. The CAC provides guidance to the Board of Directors on programs and policies that impact all communities, including overburdened communities.

The CAC reflects the diversity of the Bay Area and lived experiences in communities heavily impacted by air pollution. The CAC is composed of individuals with diverse skill sets and a range of relevant knowledge and technical expertise. This includes, but is not limited to, individuals who reflect the diverse demographics of the Bay Area and/or have been or are impacted by air pollution, as well as individuals who utilize community-centered approaches and have expertise and knowledge on air quality issues.

The CAC meets bi-monthly in person and members are expected to:

- Review materials for CAC meetings and participate during the meetings;
- Attend required trainings;
- Join at least one ad hoc committee every year, except CAC leadership;
- Perform all other duties as prescribed by the Charter, including following Civility expectations.

Council Members are compensated \$500 for attending the bi-monthly CAC meetings and \$75 per hour for other meetings.

Proposed BAIFA Toll Ordinance Amendment 2025



The Bay Area Infrastructure Financing Authority (BAIFA) is proposing changes to the existing Toll Facility Ordinance to support the opening of new

Express Lanes on Interstate 80 (I-80) in Solano County and to update selected policies for all BAIFA Express Lanes in the Bay Area.

Proposed Toll Ordinance Changes in 2025

The proposed changes will allow BAIFA to apply its toll policy to the new Interstate 80 (I-80) Express Lanes in Solano County, which are scheduled to open in Fall 2025, and make other updates to the

policies for all Express Lanes. The changes to the toll ordinance will allow BAIFA to:

1. Include the new Solano County I-80 Express Lanes in BAIFA's toll policies
2. Have more flexibility for Express Lanes pilot projects, including the allowed timeframe and parameters for pilot projects
3. Increase the minimum toll per zone from \$0.50 to \$0.75 for all BAIFA Express Lanes
4. Clarify that the Clean Air Vehicle (CAV) discount will end in September 2025 (unless federal law changes before the current expiration date)
5. Adjust the boundaries of the toll zones on southbound Interstate 680 (I-680) to reflect the gap closure between BAIFA's and Alameda County Transportation Commission's (CTC's) Express Lanes on I-680

Bay Area Butterfly Festival



Monarch butterflies play a crucial role in regulating our ecosystems and pollinating plants — including the crops we rely on for food. One out of every three bites of food we eat is thanks to pollinators like the Monarch butterfly. Without pollinators, our entire food web could unravel.

After two years of counts averaging 116,000 Western Monarch butterflies, only 5,407 of these orange-and-black beauties were counted in their winter groves during the most recent winter. (Data from Xerces Society.) This population count shows a heartbreaking decline of 95% for Monarchs, who are dying off due to pesticides and habitat loss.

You can learn more about Monarchs and how to support them at the Bay Area Butterfly Festival on **Sunday, June 1 at the Mare Island Promenade in Vallejo from 10 a.m. - 5 p.m.** There will be fun for the entire family, with interactive stations, presentations,
