On April 25, 2024, in recognition of National Crimes Victims' Rights Week, the Solano County District Attorney's Office joined forces with Vacaville and Fairfield Police Departments for a Moment of

Reflection. District Attorney Krishna Abrams praised victims and survivors for the ongoing strength, bravery, and courage they exhibit through the toughest of times. "Victims are truly the untold story of a prosecutor. There is so much talk about defendants and their rights that we often lose sight of those whose lives have been impacted by these defendants' actions, and these are the people whose voices must be heard," said District Attorney Abrams. Arlena Moran, now an advocate for victims, shared a heartbreaking story of her life as a domestic violence victim and how she and her young children overcame the many challenges they faced. She credited Fairfield Police Department Domestic Violence Program Manager Lilia Breaux for helping her get out of the abusive situation she was in and inspiring her to become a successful advocate for other victims.

and prosecutions by allowing this precise and comprehensive information during courtroom proceedings. We are excited to implement these advanced tools, as they will contribute to the pursuit of justice in our community.



### FENTANYL AWARENESS "ONE PILL CAN KILL"



The Solano County District Attorney's Office is trying to combat the fentanyl crisis on many fronts by confiscating illegal drugs, prosecuting those who sell and furnish illegal drugs, and bringing public awareness to the dangers of fentanyl.

Our investigators, together with all of our law enforcement partners are actively working to disrupt the surge of counterfeit drug production and seize any contraband coming into Solano County.

Our office is also actively engaged in a fentanyl awareness campaign to help prevent fentanyl related deaths throughout our county. We want to thank our partners, Public Health Officer Dr. Bela Matyas, Fairfield Fire Dept., Benicia Fire Dept., Vallejo Fire Dept., and Danielle Manno, who have joined our efforts in bringing awareness to our local high schools about the dangers of fentanyl. Thank you to all of the schools who have participated in our campaign. We are grateful to have special guest Danielle Manno, who courageously shares her story of losing her son to fentanyl in

# **MISDEMEANOR TEAM**

We want to recognize our dedicated prosecutors on the Misdemeanor Team. Although the ultimate consequences in misdemeanor cases can be far less than felony cases, the amount of work involved for the prosecutors is still significant. Every prosecutor on our misdemeanor team works long and extended hours handling a voluminous caseload. Over the last 5 months, in addition to reviewing and filing cases, attending court for arraignment, calendar, and evidentiary hearings, our misdemeanor team conducted 35 jury trials. A majority of those jury trials (24) were for driving

under the influence of alcohol or drugs. It's important to remember that driving under the influence endangers the lives of all those who use our roadways. Our office believes in accountability for those who commit crimes in



our county from misdemeanors to murders. We are grateful to have such dedicated and hardworking prosecutors who seek to do justice every day.
